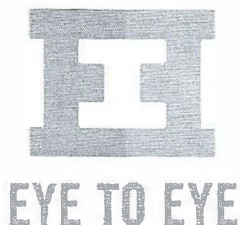


**CONTRACT NAME: AGREEMENT BETWEEN EYE TO EYE AND DAVIS
