WHEREAS, the life of César Chávez transcends any one cause or struggle. He was a unique and humble labor leader, and a great humanitarian and communicator who influences and inspired millions of Americans from many diverse walks of life to seek social justice and civil rights for the poor and disenfranchised in our society; and

WHEREAS, the California Department of Education has developed and made available a Cesar Chavez Day model curriculum for teachers for grades K-12; and

WHEREAS, the Governing Board of the Davis Joint Unified School District recognizes the contributions and accomplishments of César Chávez.

**RESOLUTION NO. 19-20
FRED T. KOREMATSU
JANUARY 30, 2020**

WHEREAS, the battle for civil liberties has been championed by ordinary Americans who have had the courage to stand up and fight for their basic Constitutional rights; and

WHEREAS, Fred T. Korematsu was one of these individuals, who refused to comply with Civilian Exclusion Order 34, based on the federal Executive Order 9066, which imposed strict curfew regulations and required 120,000 Japanese Americans to leave their homes to be incarcerated in American concentration camps during World War II; and

WHEREAS, Mr. Korematsu was arrested and convicted, but fought back because he believed the conviction went against the basic freedoms guaranteed to him by the U.S. Constitution, and

WHEREAS, Mr. Korematsu's conviction was ultimately overturned in 1984; a decision that influenced the US government's passage of the Civil Liberties Act of 1988, which recognized that a grave injustice was done by forced relocation and incarceration of civilian Americans because of wartime prejudice; and

WHEREAS, current California law designates a number of days as having special significance, when public schools are encouraged to observe and conduct suitable commemorative exercises as specified; and

WHEREAS, the *History-Social Science Framework for California Public Schools, Kindergarten Through Grade Twelve*, adopted by the State Board of Education in 2016, states that we want our students to develop respect for all persons as equals regardless of ethnicity, nationality, gender identity, sexual orientation, and beliefs; and

WHEREAS, the California Assembly and State Senate passed AB 1775, commemorating January 30th as Fred Korematsu Day of Civil Liberties and the Constitution - the first day named after an Asian American in US history, without opposition and Governor Arnold Schwarzenegger signed this bill into law on September 23, 2010: 1.1-C

WHEREAS, the Supreme Court in *Trump v. Hawaii* acknowledge that "Korematsu was gravely wrong the day it was decided, has been overruled in the court of history, and – to be clear – 'has no place in law under the Constitution.'"

NOW, THEREFORE, BE IT RESOLVED, that the Governing Board of the Davis Joint Unified School District encourages all schools and teachers to observe January 30, 2020, as Fred T. Korematsu Day of Civil Liberties and the Constitution and conduct exercises commemorating the life of Fred Korematsu and recognizing the importance of preserving civil liberties, even in times of real or perceived crisis.

WHEREAS, Filipino American History Month was first proclaimed by the 111th Congress of the United States in November 2009; and

WHEREAS, the California Department of Education first recognized Filipino American History Month in 2006 by placing it on its celebrations calendar. In September 2017, the California State Legislature also recognized October as Filipino American History Month.

WHEREAS, Filipino American servicemen and servicewomen have a longstanding history of serving to protect and defend this country in the Armed Forces, from the Civil War to the Iraq and Afghanistan conflicts; and

RESOLUTION NO. 22-20

Larry Itliong Day

WHEREAS, Larry Itliong was a native of the Philippines and was born on October 25, 1913, in San Nicolas, Pangasinan; and

WHEREAS, at 15 years of age with only a sixth grade education, Larry Itliong moved to the United States of America in 1929. As a result of the Great Depression, Larry Itliong was forced to work on the railroads and then as a migrant farmworker traveling through Montana, South Dakota, Washington, and finally California. During that time, Larry Itliong learned of the plight suffered by Filipinos and other immigrants working as farm laborers; and

WHEREAS, Larry Itliong was a prominent leader in the American farm labor movement. He organized a group of 1,500 Filipinos to strike against the grape growers of Delano, California, and continued on that strike for eight days while suffering through violence imposed by the growers' hired hands and the sheriff's department; and

WHEREAS, despite this treatment, Larry Itliong remained tenacious and resilient, calling upon César Chávez and his followers to join forces with the Filipinos and strike together. Due partly as a result of Larry Itliong's persuasiveness, the two groups combined, establishing the United Farm Workers of America Organizing Committee of the AFL-CIO, which led to the United Farm Workers of America; and

WHEREAS, Larry Itliong moved on to become the President of the Filipino American Political Association, the first national political Filipino American organization and a crucial alliance between Filipino professionals and laborers that grew out of the Delano Grape Strike; and

WHEREAS, Larry Itliong was also instrumental in the founding of the Pablo Agbayani Village, a retirement home built by volunteers for retired Filipino Manongs who no longer had families and needed a place to call home; and

WHEREAS, Larry Itliong passed away in 1977 at the age of 63 leaving behind his wife and seven children.

WHEREAS, California passed legislation in 2015 to establish October 25 as Larry Itliong Day to encourage public schools and educational institutions to remember the life and contributions of Larry Itliong; and

WHEREAS, the accomplishments and contributions of Larry Itliong should be properly memorialized within the history and culture of the United States of America.

WHEREAS, Gun Violence Awareness Day was created to honor the many lives that have been cut short by gun violence in our country and to support efforts to reduce gun-related crimes in the United States; and

WHEREAS, It is important to recognize community organizations which assist families that have been directly impacted by gun violence and provide a continuum of care to grieving parents or spouses who must continue to provide for surviving family members; and

WHEREAS, The Davis Joint Unified School District supports continued statewide efforts to strengthen gun safety laws and educate the community on safe gun storage; and

WHEREAS, It is appropriate to set aside a day to honor those Americans whose lives are cut short each year by gun violence, and the countless survivors whose lives are forever altered;

WHEREAS, every day, 100 Americans are killed by gun violence and on average there are nearly 13,000 gun homicides every year; and

WHEREAS, Americans are 25 times more likely to be killed with guns than people in other high-income developed countries; and

WHEREAS, protecting public safety in the communities they serve is the district's highest responsibility; and

WHEREAS, support for the Second Amendment rights of law-abiding citizens goes hand-in-hand with keeping guns away from dangerous people with dangerous histories; and

WHEREAS, in January 2013, Hadiya Pendleton, a teenager who marched in President Obama's second inaugural parade and was tragically shot and killed just weeks later, should be now celebrating her 22nd birthday; and

WHEREAS, to help honor Hadiya – and the 100 Americans whose lives are cut short and the countless survivors who are injured by shootings every day – a national coalition of organizations has designated June 7, 2019, the first Friday in June, as the 5th National Gun Violence Awareness Day; and

WHEREAS, the idea was inspired by a group of Hadiya's friends, who asked their classmates to commemorate her life by wearing orange; they chose this color because hunters wear orange to announce themselves to other hunters when out in the woods and orange is a color that symbolizes the value of human life; and

WHEREAS, anyone can join this campaign by pledging to Wear Orange on June 5th, the first Friday in June in 2020, to help raise awareness about gun violence; and

WHEREAS, by wearing orange on June 5, 2020 Americans will raise awareness about gun violence and honor the lives of gun violence victims and survivors; and

WHEREAS, we renew our commitment to reduce gun violence and pledge to do all we can to keep firearms out of the wrong hands, and encourage responsible gun ownership to help keep our children safe.
