Valley Precision Grading, Inc. is please to submit the following proposal to remove and replace the existing turf system and supply and install AstroTurf 3D3 60 synthetic turf. Estimated square footage of 90,000. Final square footage to be confirmed prior to final contracting price.

All pricing includes all labor, materials, taxes, tools and equipment:

SCOPE INCLUDES THE FOLLOWING:

- 1) Removal and Disposal of the existing turf system
- 2) Regrade existing stone to planarity
- 3) Install Enplast Shock drain pad system
- 4) Install AstroTurf 3D3 60 Synthetic Turf
- 5) Infill per specifications – Hemp EPDM, Zeolite and Silica Sand layered system
- 6) Football, Soccer and LAX game markings per NFHS guidelines – per rendering supplied.
- 7) Field safety testing at completion
- 8) Sweeper Unit
- 9) Center field logo with standard coloring – per rendering supplied.
- 10) Colored end zones with “Davis” in each end zone
- 11) 3rd Party Insured Warranty
- 12) Provide and install Kifco water reel and connector box – within field area. Any boring, water supply to field will be additional cost
- 13) Relocate quick coupler from inner track to field sideline and patch track
- 14) Provide and Install Lacrosse Protective Netting System (432 LF)
- 15) NIPA Cooperative Purchase Fee – 2% of total contract value (\$22,397.22)
- 16) Construction Contingency - \$101,806, the use of this allowance is to be authorized by written directive from DJUSD. Any unused/remaining allowance shall be returned to DJUSD.
- 17) Pricing is determined by NIPA agreement

Total Project Cost: \$1,119,861.00

Exclusions:

- Any work, materials or labor not directly included and/or state above.

- No Mirfi Fabric or liner under pad system
- Any field graphics or logos not listed on bid plans and/or documents.
- Any sports event equipment outside of the lacrosse netting scope of work.
- SWPPP measures of any kind.
- Fabric and/or installation of any kind.
- **ANYTHING NOT INCLUDED IN ABOVE SCOPE**
