3. Program cancellations made three weeks (21 days) prior to the event are entitled to a refund of all fees paid. Cancellations made less than three weeks prior to the scheduled event will forfeit the entire contracted amount.
4. We reserve the right to cancel or reschedule your event due to safety concerns. Such cancellations will not result in forfeiture of fees.
5. It is your responsibility to ensure that all participants wear closed-toe shoes and have signed the Challenge Center Waiver and Medical Information form. Participants that do not meet these requirements will not be allowed to participate.
