PAYMENTS AND CONDITIONS, Group Agrees to the Following:

1. To provide its own leader and chaperones to set the rules and to supervise the behavior and welfare of the tour participants.
2. To have all payments and all required documents to American Classic Tours as per the Payment & Deadlines Schedule on the following page.
3. Late payments will incur a \$100 fee. Payments received within 30 days of departure will incur an additional \$75 to cover late processing fees.
4. Cancellations occurring more than 120 days prior to departure will result in a full refund less any non-refundable amounts paid to suppliers to confirm your reservations.
5. Cancellations occurring 119-60 days prior to departure will result in a cancellation fee equal to the initial deposit plus any non-refundable additional amounts paid to suppliers to confirm your reservations.
6. Cancellations occurring from 59 days up to 31 days prior to departure will be assessed cancellation fees of 20% of the Tour Cost and any non-refundable amounts paid to suppliers to confirm your reservations.
7. Cancellations occurring within 30 days of departure will receive no refunds.
8. To the Group Terms and Conditions attached hereto as Exhibit "A".
9. To the Tour Inclusions attached hereto as Exhibit "B".
10. Group understands that American Class Tours will require participants or their parent or guardian to agree in writing to its Participant Terms and Conditions attached hereto as Exhibit "C".
11. Any controversy or claim arising out of or relating in any way to these Terms and Conditions, to this Tour Agreement, to the brochure, or any other information relating in any way to the trip, or to the trip itself, shall be settled solely and exclusively by binding arbitration in New York City, New York in accordance with the rules of the American Arbitration Association then existent.
In any such arbitration, the substantive (but not procedural) law of New York will apply. The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable.

TOUR COST

The following Tour Cost is based on a minimum of 28 paying participants, and 2 Free Tour Leaders. A change in this configuration will affect the tour cost.

- The cost of the program is based on the value of the Euro as of today, **September 23, 2019**. In the event of a change, we reserve the right to adjust the land cost accordingly up until final payment is received.
- Airfare taxes and fuel surcharges are subject to a possible increase until final payment is made. Baggage fees are not included.
- The Tour Cost may be adjusted any time after the signing of this agreement as a result of requested or required changes (e.g. based on supplier availability) to the Tour Inclusions, itinerary or group size. Any changes to the Tour Cost will be reflected on Group's final invoice.
