### **ATHLETE OF THE MONTH CONTEST RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. THE CONTEST IS VOID WHERE PROHIBITED BY LAW.**

1. **How to Enter the Contest:**

- (a) The Athlete of the Month contest will begin on 9/5/19 and end on 5/26/20. Contest is sponsored by KOVR Channel 13.
- (b) Each week (for the duration of the contest), CBS13 Sports will select one high school student in the Sacramento-Modesto-Stockton area who, in the estimation of CBS13, is the best athlete of the week based on a combination of their statistics, game information and value to their team or school (as determined by CBS13 Sports). CBS13 Sports will select one athlete a week from among students at similar sized high schools. CBS13 Sports will select 3 athletes each week from a large high school one month, 3 athletes from a medium-sized school the next month, and 3 athletes from a small/private school the following month, and repeat this pattern throughout the contest. To participate in the contest, you must be a high school student playing on a high school team(s). For the first three weeks of any month during the duration of the contest, one of the CBS13 News sports anchors (Sara Hodges, Joe Musso and Marshall Harris) will select an athlete from a high school. The station will then profile that high school athlete each Thursday on the CBS13 News at 10pm. After three athletes a month have been profiled, viewers will be given the chance to vote for their favorite athlete with polls opening after the final of the three athletes has been profiled (after the third Thursday). Voting will continue until the following Tuesday until noon. The winner will be determined by the top vote getter.
- (c) **Viewers can only vote once.**
- (d) Sponsor is not responsible for technical or computer failures, errors or data loss of any kind, lost or unavailable Internet connections, or failed, incomplete, garbled or deleted computer or network transmissions, inability to access any Web site or on-line service, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. If the judges determine, in their sole discretion, that there is any suspected or actual electronic tampering with the Contest or if technical difficulties compromise the integrity of the Contest, the judges reserve the right to void the entries at issue and/or terminate the Contest and conduct a random drawing to award the prize among all eligible entries received as of the termination date. 2. Eligibility Restrictions:

Student participation is contingent on the approval of their parent/guardian (if under 18) and their school. Participants must be enrolled at a high school in the Sacramento-Stockton-Modesto area and cannot be an employee nor immediate family member or persons living in the same household as employees of **KOVR/KMAX**, CBS Corporation, other television and radio stations in the **Sacramento/Stockton/Modesto** market, and their affiliates, subsidiaries and advertising agencies.

3. Prizes:

- (a) One Grand prize will be awarded each month. The Grand Prize is a \$500 donation to the school the student attends and a plaque to the student. Total \$545.
- (b) The prizes will be announced on the 4<sup>th</sup> Thursday of each month during the CBS13 News at 10pm.

Any prize or prize certificate not claimed within thirty (30) days of winning will be forfeited by the winning school. - (c) In case of a tie breaker, the sports anchors will decide the winner.
- (d) Athlete candidates will be selected based on their stats in the game and value to their team/school.
- (e) Winners need not watch/listen or be present to win

5. Conditions:

- (a) Payment of all federal, state and local taxes are the sole responsibility of the winner and winners may receive an IRS Form 1099 or equivalent from Station.
- (b) By participating in the contest, the winners (or, in the case of a minor, their parent/legal guardian) agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest, and to sign a publicity release, affidavit of eligibility and release of liability prior to acceptance of the prize. **If a prize winner is a minor, prize may be awarded to the minor's school, parent or legal guardian.** The financial prize will be picked up by an authorized representative of the school. By accepting the prize, each winner grants to Station the right to use the winner's name, voice, picture and/or likeness for purposes of advertising and publicity in any and all media now known or hereafter invented, without further permission or additional compensation (except where prohibited by law).
