Spirit Airlines Group Travel Policy

- A Group Sales Specialist will be assigned to each group contract and will communicate with the group representative upon acceptance of contract and receipt of deposit. All updates/communication regarding this group contract must be done through your group representative.
- A non-refundable \$5 group booking fee per passenger will be collected at the time of booking and it will not apply towards the cost of the ticket. Non-refundable deposit of \$40 USD per passenger is due within 7 days of creation of contract (if applicable). The final payment is due 60 days prior to departure date. Block space may be downsized up to 60 days before departure. **All payments and fees for space held and released are forfeited.** ** Automated emails regarding travel credit does not apply towards groups **.
- A signed contract, full payment, and name list along with date of birth and gender are due on the day of booking for all travel **"inside"** of 60 days before departure. Blocked space will be released if the contract and payment are not received by 5 p.m. on the day of the booking.
- Names, date of birth, and gender are due 60 days prior of departure. Name changes must be requested in writing by fax or email to your Group Sales Specialist and will be acknowledged by fax or email. There is no charge for name changes up to 30 days before departure. Between 30 days and seven (7) days, there is a \$50 USD service fee per name change. No name changes are allowed **"inside"** of seven (7) days of travel.
- Once full payment has been received for a group contract; the reservation may be placed on temporary hold for the entire group with a 30 day advance notice to the Group Department. A credit shell for the value of the reservation, minus the **\$40 USD non-refundable** deposit, and the **\$50 USD service fee** per person will be charged when the voucher is created. Credit shells are non-transferable and must be used towards a new booking within **60 days** of issuance.
- Fare adjustments are not permitted on guaranteed airfare for group travel. Seats may not be increased on said contract after initial quote. **No individual changes are permitted.** Requests for additional seats will be priced at current available airfare (minimum 10 seats). A group must keep a minimum of 10 seats or the reservation will be forfeited

- Modifications of any sort to this contract are not permitted without written consent of the customer and the airline. Due to limited availability, initial deposit and final payment due dates will not be extended.
- Spirit Airlines reserves the right to release seat blocks if terms outlined in this contract are not met by the customer.
- Spirit Airlines reserves the right to change equipment or schedules without notice. We will not be liable for delays or cancellations due to weather, Air Traffic Control issues or any other cause beyond the control of Spirit Airlines. Groups will be accommodated on the next available flight due to cancellations or schedule changes. All transportation is subject to Spirit Airlines' published Contract of Carriage.
- Inquiries on completed group travel must be submitted in writing by the group representative to Spirit Airlines within 30 days of the return date of travel.
- Proper identification along with proof of citizenship and visa (where required depending upon travel itinerary) is required at check-in on the day of departure. Customers who arrive late for check-in or no show for their flight may face forfeit of entire airfare.

Prohibited Hazardous Materials: Federal law forbids the carriage of hazardous materials aboard aircraft in your luggage or on your person. A violation can result in five years' imprisonment and penalties of \$250,000 or more (49 U.S.C. 5124). Hazardous materials include: Explosives (Fireworks, Flares), Compressed gases (Oxygen bottles), Flammable liquids and solids (Paints, Gas engines, Camp stoves), Oxidizers, Poisons, Corrosives (Cleaners), Radioactive materials and Tear gases. Spare Lithium Batteries cannot be in checked baggage. There are special exceptions for small quantities (up to 70 ounces total) of medicinal and toilet articles carried in your luggage and certain smoking materials carried on your person. For further information contact your airline representative.

Group reservation passengers require airport check-in. Check-in begins generally three (3) hours before departure at the Spirit Airlines ticket counter. Customers checking in must do so at least 30-45 min (Domestic) and 60 min (International including the U.S. VI) prior to posted departure time. Spirit Airlines will charge a fee for carry-on and checked luggage. One (1) personal item is allowed at no charge (e.g. purse, small backpack, briefcase, etc.). Dimensions must not exceed 18" x 14" x 8" inches including handles and wheels. One (1) carry-on bag is allowed and may not exceed 40lbs and 22 x 18 x 10 inches (56cm x 46cm x 25cm) including handles and wheels. We may require that a carry-on bag travel as a checked bag if it cannot be safely stowed on a particular flight. Checked bags must not exceed 62 linear inches (length + width + height; 158 cm) in overall size including handles and wheels and 40lbs in weight (8.1 kg). We will not accept bags that weigh more than 99 pounds (45 kg), measure more than 80 linear inches (203cm) in a single dimension or have a combined size of 160 linear inches (406cm). We recommend to pre-purchase bags or seats online prior to travel. Please visit www.spirit.com.
