AMENDMENT
TO THE Agreement Between
Big Picture Learning
AND
DAVIS JOINT UNIFIED SCHOOL DISTRICT
(Venue and Data Privacy Law)

This Contract Amendment executed by Big Picture Learning hereinafter referred to as "Vendor", and Davis Joint Unified School District, hereinafter referred to as "District", which document shall amend the ImBlaze Proposal Agreement between the Vendor and District ("Service Agreement") as follows:

1. The ImBlaze Proposal Agreement shall be governed by and construed in accordance with the laws of the State of California and all disputes arising out or relating to the ImBlaze Proposal Agreement shall be heard in Superior Court in Yolo County, California.
2. The parties agree to adopt the California Student Data Privacy Agreement ("CSDPA"), the contents of which are incorporated herein by reference. In the event there is a conflict between the CSDPA and the Service Agreement, the CSDPA shall apply and take precedence.

Subject to the terms and conditions set forth in this Amendment, the above referenced Service Agreement between the parties is hereby ratified and confirmed.
