The attached estimate is based on information supplied at the time of booking and is subject to change according to actual services rendered. The chartering party will be responsible for all tolls, parking & entrance fees, including lodging for the driver on over the road charters. The use of tobacco products is strictly prohibited on all vehicles. Department of Transportation regulations state it is unlawful for a motor coach to carry kegs or glass containers, the use of these items is strictly prohibited. The use of alcoholic beverages for anyone under the age of 21 is prohibited and failure to comply with this policy may result in immediate termination of the charter. The group leader on the charter holds responsibility in entirety for the verification of all passenger ages. Western Motorcoach will not be held liable for any items lost or left on buses or for lost time due to acts of God, breakdowns, road conditions, or any other conditions beyond our control. Western Motorcoach reserves the right to lease equipment from other companies to fulfill this agreement.

Deposits are required on all charters. All convention shuttles using multiple buses require full payment before initial start date and a credit card will be placed on file for any overages that occur during the convention. All charters require a 25% deposit at the time of booking. There will be no refunds on deposit. The balance of the quoted price and a detailed itinerary will be due 15 days prior to the departure date. All clients must provide Western Motorcoach with a valid credit card in order to finalize the reservation. This card on file will serve as an insurance policy for any damages or overages that may occur during the duration of the charter(s). A cancellation fee for 25% of the quoted price will be charged on all charters cancelled prior to 15 days of the departure. Charters cancelled within 15 days of departure will pay the full amount of the quote given. The chartering party will be responsible for all repairs and for lost revenue in the event that damage is caused during your charter. A \$250 cleaning fee will be charged if the equipment is left excessively dirty.

Damages: Upon completion of the charter the motor coach operator will ask for a signature on their Trip Sheet stating your responsibility for the damages and or additional hours, costing will be settled by management staff on the following business day. Department of transportation policy state a motor coach operator may be on duty for a period of no longer than 10 hours driving with an 8 hour break in between on duty times, for your safety and comfort this policy must be enforced.
