

**BOARD OF EDUCATION
DAVIS JOINT UNIFIED SCHOOL DISTRICT RESOLUTION NO. 56-20**

(Resolution Ordering Governing Board Member Regular and Special Elections and Requesting the Boards of Supervisors of the Counties of Yolo and Solano to Consolidate District Elections with Regular Election Held on November 3, 2020)

WHEREAS, a regular biennial election for governing board members of the Davis Joint Unified School District is to be held on November 3, 2020; and

WHEREAS, it is desirable that the District regular and special elections be consolidated with the regular election to be held on the same date, and that within the Davis Joint Unified School District the precincts, polling places, and election officers of the two elections be the same, that the Boards of Supervisors of the Counties of Yolo and Solano canvass the returns of the District election, and that the District election be held in all respects as if there were only one election.

**NOW, THEREFORE, IT IS HEREBY RESOLVED, ORDERED, AND FOUND BY THE BOARD OF EDUCATION OF THE
DAVIS JOINT UNIFIED SCHOOL DISTRICT AS FOLLOWS:**

1. Pursuant to Education Code Sections 5304 and 5320 et seq., an election is hereby ordered to be held on November 3, 2020 to fill the offices of the Davis Joint Unified School District Board of Education members whose terms expire this year.
2. The County Clerks of Yolo and Solano Counties are hereby requested to conduct the election and provide all related election services.
3. If there is a tie vote that makes it impossible to determine which of two or more candidates has been elected, the winner or winners shall be determined by {choose one: "lot" or "run-off election"}.
4. The {choose one: "district" or "candidates"}, including incumbents, will pay the costs of publishing the candidate's statement included with the sample ballot, which statement shall not exceed {choose one: "200" or "400"} words.
5. The Boards of Supervisors of Yolo and Solano Counties ("Boards of Supervisors") are hereby requested to consent, agree to, and order the consolidation of the District's governing board member election with the regular election to be held on Tuesday, November 3, 2020, that only one form of ballot be used, and that the elections be held in all respects as one election.
6. The Boards of Supervisors are hereby authorized to canvass the returns of the District election.
7. The Boards of Supervisors are hereby requested to authorize and direct the Clerks to take any and all steps necessary for the holding of the consolidated election.
8. The Davis Joint Unified School District hereby agrees to reimburse the Counties of Yolo and Solano for the

costs of such election.

9. The Clerk of this Board is hereby directed to file certified copies of this Resolution with the Boards of Supervisors of Yolo and Solano Counties, and with their respective County Clerks or Registrars of Voters.
