**Description of Nature, Purpose, and Beneficiaries of Project:** The proposed project would include the construction/installation of a 1-story, approximately 9,620 square-foot Multi-Purpose Building (MPR) in the place of four (4) existing portable classrooms near the existing blacktop. The project will include the relocation of the four (4) existing portable classrooms north of the new MPR to a portion of the existing grass area. The project will also include a new playground on the northerly portion of the existing blacktop, and an expansion of the existing blacktop area (concrete and asphalt) which will include, basketball courts, four-square courts, and additional blacktop play-space. The project will include staff and student restrooms, site work, grading, fencing, utilities, and landscaping. Approximately 5 trees will be removed. Construction will commence in approximately June of 2021, with an anticipated June of 2022 completion date. This project would benefit the District staff, students, and local community.

Class 14 (Sec. 15314): The proposed project would be located within the existing North Davis Elementary campus, a developed property within the City of Davis, and will not increase original student capacity by more than 10 classrooms or 25 percent. District will be improving an already developed property, with low increased capacity.
