Thank you to the Board and guests for your hard work on this issue. Now that we have CDC recommendations for returning to school for K-12 and the data-driven acknowledgement that vaccination of all staff and teachers as a prerequisite to return to school for our children is not necessary, combined with the American Academy of Pediatrics recommendation that children return to school as soon as possible, are there any plans for the Board of Directors to re-address their plan for a return to schools? If we are close on HVAC installations and social distancing in the classroom, asymptomatic testing and symptom screening, as well as the other measures that have been addressed, can we not return to school this Spring even as we prioritize educator and staff vaccinations locally and in the county? If there is no plan to review after this new data has come to light, why not? What if some teachers decide not to get vaccinated? Will those teachers then not go back? How will that choice affect the ability of our children to return to school?

I know that an incredible amount of fear surrounds returning to closer environments before getting a vaccination, and I respect the reluctance to do so. I have been working in a COVID-inundated Emergency Department for a year without a vaccination and understand the personal risks.

As we close in on a full year out of school, how do we rationalize in light of this new information, the mental health and academic toll on children, and the financial and emotional strain on parents who do not have the opportunity to work from home? I respect the hard work that our teachers have put in by providing the best possible online academic environment for our children but it is, quite simply, not as effective as in-person instruction in my family's view.

Board members and Superintendent Bowles,

Increasing evidence continues to show that schools open for in-person instruction (both hybrid and full in-person) are safe for teachers, students, and the surrounding communities using CDC recommended mitigation measures and WITHOUT the need for teacher vaccination.

This district adopted the criteria for teacher vaccination requirements and red tier requirements and FALSELY claim them to be outside of your control. This is very much within your control- you set this criteria. The criteria you set does not align with public health science or recommendations.

It is not a mystery how to open schools safely. It is not a guess at what needs to be done to do it safely. It is documented and endorsed by the CDC and our very own local public health officer that we act with haste and urgency to re-open schools now.

Let's have some real talk here. Re-opening schools during a COVID pandemic is no longer a public health issue as it was a year ago in March 2020. Be honest with yourselves- schools are closed because of labor issues and leadership issues.

The severe negative risks to children are too great to ignore this issue any longer.

Please make a motion to either:

- a) Change the criteria for re-opening to align with CDC and local public health guidance
- or
- b) Firmly establish a re-opening date for in-person instruction of no later than 3/29/21 (allowing for 6 weeks of ample teacher access to vaccinations currently being offered through Dignity health)

Additionally- please make a motion now:

Establishing DJUSDs commitment to full in-person education for the entire 2021-2022 school year (state law allowing) and ensure that any collective bargaining for that year includes this requirement.

You have a professional responsibility to act in the best interest of the education and safety of the children in this district- especially when we know clearly that you aren't putting teachers or staff at increased risk based on public health science.

Failure to act now and ensure full in-person learning is ensured this fall will force our family with no other option but to disenroll from this district. Sadly, this decision to leave DJUSD has been shared with me by numerous other families in our town.

I want DJUSD to succeed and survive this pandemic. Viruses don't keep schools closed. People do.

Superintendent Bowes and the Trustees of the Board of Education:

We are the parents of elementary and high school students. We request that the school board reconsider its universal vaccine requirement to open the schools. Dr. Fauci said yesterday that it is “not workable” to base school reopening on this criteria. It is also contrary to science. This issue deserves renewed dialogue at the board meeting given the significant groundswell of national and local attention that is spotlighting those school districts that are not reopening. Yolo County will be in the red category next week and possibly the orange soon thereafter. Yet the Davis schools will still be closed due to the vaccination requirement. That is not furthering the interests of our students.

Also, many other boards allow for live public comment, yet the DJUSD Board requires written comments. For issues as important as reopening schools, live public comment should be implemented. It would give parents to opportunity to talk directly to the elected officials who are keeping the schools closed.

The children of our community deserve to be in school. We have supported public education throughout our lives. We are both products of the California public school system. We have voted for every DJUSD bond measure in the last 25+ years. Our two older children went through the Davis public school system and are now at public universities. However, because of the unreasonable delays in opening the Davis public schools, we transferred our 5th grade child to a private school this week. He now has full time in-person class five days a week. That is the way we should educate our children. Many other families have also left the Davis school system because of the delays in reopening the schools.

Please reconsider the roadblocks you have created to reopening our schools. The children of Davis deserve it.

Davis School Board,

I am a parent to two children in the Davis Joint Unified School District, one a Junior at Davis Senior High School and one a sixth grader at Patwin. I also have an older child that is a graduate of Davis Senior High School and is a Honors College student in her second year. Both my husband and myself are graduates of Davis Senior High School and chose to live in Davis as we believed that this school district was one that could give our children the best public education and well-rounded student experience. Given the challenges of the past year and the deterioration in the education our children are receiving through virtual learning, we need to consider the best options for our children's well being and education and will be withdrawing our children if there is not a return to full in person.

It is in a challenging position we are in. Despite our teachers' heroic efforts, distance learning does NOT meet our children's educational social, emotional and psychological needs. This is not the fault of the teachers, it's just the nature of virtual learning. It is very challenging for children to engage day after day in a virtual environment. It's very challenging for the teachers to be engaged with their students and ensure that students are understanding and learning.

There is also a mental aspect to this as we are seeing. It's difficult to get our children up in the morning and wanting to be in their virtual classes, it's even more difficult to get them to do the work. Emotional outbreaks are now common. Our children once liked school and now dread it. Our child in high school has always been strong academically especially in science and math. He's in several Advanced Placement courses and is barely passing with D's. Few of the teachers have worked with my husband and myself to try to get his grades up, and a few others have written him off as lazy as they believe kids should be performing the same as if they were in-person. College is no longer an option with these grades. My child does not feel there is any point in trying, and essentially has given up.

Decisions of feelings of perceived risk alone cannot be the only guiding source for determining if/when there is a return to the classroom, especially when it is in violation of a student's constitutional right to an equitable education.

With the appropriate safety measures in place, schools can in fact safely provide in-person instruction. Many schools across the nation, within California as well as schools within Yolo County and Davis have safely returned students to the classroom. The district has the opportunity to learn from their experiences. Schools that have reopened have successfully implemented universal masking, basic hand hygiene and messaging for kids and staff to stay home if sick. What is not required for a safe school environment is for vaccinations for all teachers, keeping children six feet apart at all times or extensive infrastructure changes. Our school already meets the precautions to safely open once community prevalence decreases. Our Yolo County Health Director has stated that kids in K-6 can return to the classroom.

In addition, Davis is unique as it has a partnership with Heatly Davis to test our community on a weekly basis.

I would ask the School Board to commit to fully reopening schools for in person instruction. This is critical for shifting the conversation into the phase of how to effectively and safely offer in person education. Promote equity and good science in communications and take a strong stand for our students in our community.

Dear DJUSD Trustees,

We have hit the 11-month mark since DJUSD schools closed their classrooms to in-person learning. DJUSD families now know that the District has an agreement with Dignity Health to provide vaccinations to teachers and school staff. I do want to congratulate you and your staff on getting together the first part of the Re-opening Plan: there are now DJUSD dedicated clinics that are providing vaccines. Please provide information at this Board meeting telling the public how this information has been disseminated to your employees. DJUSD families also know that these vaccination clinics are NOT full.

With dedicated Dignity Health vaccination clinics now offered to teachers, student teachers, and staff, the Board Trustees must set a return-to-school date if there is going to be any in-person instruction before the Fall. This is because you have no clear way for DJUSD to track teacher and staff vaccinations without potentially violating the protections under HIPAA's privacy requirements. As such, the Board and DJUSD staff have now created an impossible return-to-class metric: teacher vaccinations cannot be tracked by their employer to know when teachers have been offered and received the vaccine. In addition, DJUSD has not disclosed how they can track those teachers that choose not to be vaccinated at this time. If there is to be any in-person education for the remainder of the 2020-2021 school year, you need to direct your staff to take two swift actions:

1. There must be a DJUSD Family Return to Campus form sent out no later than next Friday, February 26th to plan for the number of students that will be back in the classroom for the remainder of this school year. Getting this information now is necessary to plan for classroom set-ups for the respective CA Department of Public Health colored tiers as well as the CDC guidance tiers. There must also be a swift deadline to get this information back from families so that the beginning of March can be spent getting the pieces in place. This will take a little time, so there can be no delay in getting the student numbers now.
2. I urge you to set the return-to-school-campus date to March 29th, 2021, which is the first day after Spring Break. Board would then be providing teachers and staff with approximately 40 days from today, February 18th, to obtain their vaccinations if desired. This is more than the 28-day time period between first and second doses and will accommodate clinic dates. If the DJUSD Board does not set a date then in-person education will not happen this school year. It's that simple.

I am pleased teachers are being vaccinated in Yolo County, and that our county is transitioning from Purple to Red. This should mean the Board can move forward establishing a timeline for reopening elementary, junior high, and high schools. Please plan a timeline now, so that everyone can prepare for reopening. Please reopen all schools as soon as possible. Every day of learning matters to us. Even with the strict rules DJUSD has currently established, it should be possible to reopen all schools April 5th.

Teacher vaccines first dose February
Second dose March
Reopen April 5th!!!!

The CDC and Aimee Sisson recommend reopening elementary schools now, rather than waiting for teachers' vaccines, and I believe that is safe with the level of testing possible now in Davis. If you want to make that happen, maybe tell families that if they want their children to attend in person next week, have them tested at their school this week. Would teachers fear teaching masked children if they had all tested negative the week prior? We have amazing testing resources here. Let them help our students return to school now.

You all know how you feel after a Zoom meeting. You probably don't spend 3.5 hours on Zoom every weekday. Our children do! And they have done this for a year! My children (ages 11, 14, & 17) have been much more isolated than my parents (ages 75 & 76) and that is WRONG. Children around the world have attended school this year, because other countries see EDUCATION as ESSENTIAL. It is essential, and Zoom learning is not the same. My 17 year old, and his friends, spend almost all their time online alone in their rooms. I see 'Davis High School Class of 2021' signs all around our neighborhood, but it has been weeks since I've seen one of these graduating seniors outside their homes. My 14 year old is the opposite. He gets outside every day, but misses Junior High sports, and the school hasn't announced any plans for junior high spring sports. My 6th grader is just wondering if this will ever end, since she has spent about a tenth of her life in quarantine, and about a 5th of the life she remembers. Even with the support we can offer her, she is upset by online school at least once a week.

For the youngest learners, online learning is nearly impossible, but for older kids, the emotional toll is horrible. Older kids and teens need interaction with peers. They need a reason to get up and get out each day, and school should be that reason. Please reopen schools at all levels as soon as possible.

Dear Superintendent Bowes and Board of Education,

Your focus has become singular. The only concern regarding in person education ever brought forward is COVID-19. There are many other issues facing children that you are failing to recognize. These include children with significant weight gain, depression, anxiety, suicidal ideation, and children experiencing abuse and neglect. Children that used to be model students are failing classes, refusing to participate in yet another day of Zoom education, feeling hopeless, feeling like they are stupid. Special education students have stopped receiving services and are losing the progress they struggled so hard to make at an exponential rate. It has been ONE YEAR of remote learning. That is far too long.

The NY Times recently published an article in which 175 pediatric disease experts concluded that vaccines are not necessary to reopen schools safely. The California Department of Public Health, the Yolo County Health Officer, the Center for Disease Control, the American Academy of Pediatrics and Dr. Fauci agree, and yet you have not managed to move this boulder forward.

Private schools are open and making this work. Their teachers are not vaccinated, they have not received government funding, and yet it is working. ABC just summarized this disparity in a news release:

California school reopening map shows private schools opening in-person where public schools aren't. These private schools are in the same areas serving the same community. Private schools have made the commitment to education where the public system has not. And more and more families are leaving the district for this very reason.

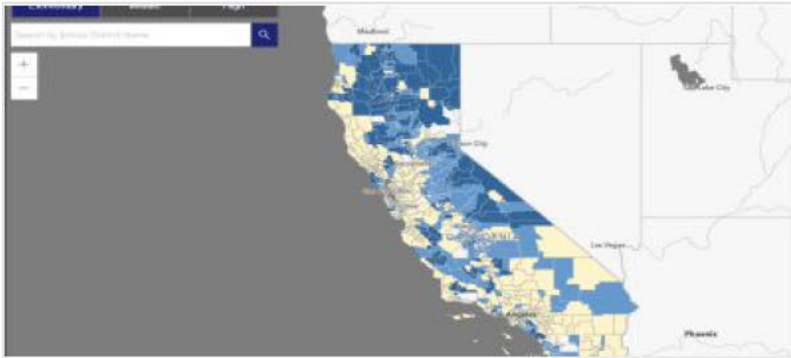
If you, the BOE and Superintendent Bowes, insist that teachers must have the opportunity for vaccination prior to returning to the class rooms, then you need to unequivocally state the date that class rooms will open. As a group, you have failed to aggressively plan to date. These endless surveys and models that keep getting put forward have begun to feel like delay tactics. So, now is the time. If you are prioritizing teacher vaccines, then you **MUST** pay it back with a solid and firm time line for reopening in person education. That is not only fair, but ethical.

Now that you are aware that schools can be opened safely without a vaccine and that vaccines became available to teachers and staff as of February 15th, you **MUST** set a date for in person instruction. I would propose you move to ensure schools are open by the first day after spring break, March 29th, a full six weeks after vaccines became available to teachers. This allows sufficient time for both access and preparations, which should start

immediately. Please show the community the urgency and commitment you have to the wellbeing of the children by setting a firm date to reopen schools.

Greetings DJUSD,

I am a parent of two daughters in the district, one is in fourth grade, and the other is in fifth. I am a PhD Candidate in Chemistry currently homeschooling both of my kids through DSIS due to the failures of distance learning. It's impossible to provide a high quality education to my kids while teaching university students and conducting research in lab, but homeschooling is better than struggling with distance learning for us.

With Yolo County's new cases numbers decreasing into the California Red Tier and new CDC Orange Tier, it is time to plan to open our schools for in person instruction, even if it's reduced. The default position by the district should involve getting kids into school as much as the guidelines allow for. This means we should have in person instruction for elementary schools in some form as soon as allowed by the new guidelines. The board and superintendent need to do what's necessary to have a plan in place that allows children in school when guidelines say we can. We should also be ready to move into the new CDC Yellow Tier, which allows for full in person instruction for K-12.

Dr. Fauci and the new CDC director have recently stated teacher vaccination should not be a requirement to return to school. Do not add requirements on top of what our public health officials recommend. Public health officials are already generally quite conservative about their approaches to returning kids to school, and of course they have considered the safety of teachers when making their recommendations.

Teaching our kids is the primary function and obligation of our public schools, and this includes having students in school when allowed by public health officials. Please stop stalling and delaying, if other schools all across the country can make it happen, so can we. Dear members of the board of education,

I am a parent of a kindergartener in DJUSD. I am writing to you today to implore you to follow science. Please remove the requirement that teachers receive both vaccines plus two weeks off prior to a return to campus, so that the hybrid model can be executed as soon as possible.

Multiple experts, including Dr. Fauci, the CDC, and Dr. Sisson have made clear that full teacher vaccinations are not a requirement for a safe return to school. Further, there is no scientific evidence to suggest that 2 weeks are needed to recover from the second vaccine. If a teacher has an extreme reaction to the 2nd vaccine requiring more than a few days off, that should be dealt with on a case by case basis because this is the minority reaction, not the majority.

In the fall there were many unknowns regarding covid. However, since then, there has been significant evidence to support the conclusion that transmission risk in schools is low. According to the CDC, in a Science Brief updated on February 12, 2021, "Based on the data available, in-person learning in schools has not been associated with substantial community transmission." (https://www.cdc.gov/coronavirus/2019-ncov/more/science-and-research/transmission_k_12_schools.html)

Anecdotally, my own children's experience with in-person learning and that of countless others in private schools throughout Davis and beyond demonstrate that in-person schooling can be done with proper measures in place. Since the summer, my children have attended in-person childcare at a large center in Davis. We made the decision to send our kids to childcare with concern for the possibility of contracting covid, but we had little choice. My husband, a pediatrician, and I, an attorney, who have no family in the area, found it untenable to give our children stimulating and fulfilling care while maintaining our workloads. Once kindergarten started, we have been blessed by the childcare provider's decision to help our daughter and others with distance learning.

At their childcare center, children wear masks indoors and out, they wash hands regularly, parents aren't allowed in the classroom, and children/staff are not allowed at school if they have any symptoms. The students range in age from infant to 6, so are probably not the best at maintaining a distance with classmates, and there are over 20 children in the preschool classrooms with 3 teachers. Nevertheless, despite having some positive covid cases acquired outside school, there has been NO in school transmission or outbreaks of covid that I am aware of. I've heard similar stories of children and staff attending/working safely in person school at private schools all over Davis. It is clear that schools can safely reopen with proper precautions in place without the need for staff to be fully vaccinated.

As published in the Davis Enterprise, "Health Officer Dr. Aimee Sisson weighed in on both a return to the classroom and resumption of high school sports. Her verdict: students from transitional kindergarten through sixth grade can safely return to school now; junior high and high school students must wait; and high school athletics that involve close contact continue to pose significant health risks."

Please listen to Dr. Sisson, Dr. Fauci, the CDC, the other experts, and the growing list of school districts in California who have started/plan to return children to school without full teacher vaccinations, starting with elementary students (Natomas, Folsom, Roseville, San Ramon Valley Unified, Los Gatos, Palo Alto, and Castro Valley, just to name a few). By imposing such stringent reopening guidelines that are not supported by scientific evidence, you are doing a disservice to all of the children in this community who need some form of in-person schooling. As noted above, I am fortunate that my daughter has an in-person experience, so at the end of the day we do not have to rely on DJUSD for some of the benefits that in-person school provides. Not everyone has that option. Also, is it fair that only people who can afford a private program get in-person instruction? Please do your part to not further propagate educational inequality in Davis. I ask you to remove the excessive vaccine requirements and not let the children of DJUSD suffer with full distance learning any longer than they have to.

For those proponents of keeping schools closed, please remember that distance learning is still an option under the hybrid model - nothing is lost by allowing others to return in person when all evidence shows it can be done safely.

Dear Superintendent Bowes and Board of Education,

Every day, every week, every month that schools are closed, children are being harmed.

The district regularly monitors covid numbers and hospitalizations. Your responsibility for community wellbeing extends beyond a single malady. At a recent meeting, a local pediatrician spoke about children with massive weight gain, children with depression, children with anxiety, children with suicidal ideation, children experiencing tremendous abuse. Children who are not safe are increasingly unsafe every day that school is closed. Children left home alone, children taking other jobs, children caring for their siblings, children disconnecting from their studies, children pursuing GEDs instead of college educations, children dropping out. Have you looked at the nearly 50 percent increase in suicide related call volume by Yolo County youth to crisis line? Where does that fit into keeping our children and our community safe?

An acquaintance who leads a non-profit serving disadvantaged children shared the article by the New York Times, in which interviews with 175 pediatric disease experts concluded that vaccines are not necessary to reopen schools safely. "I am ringing the alarm bell that we cannot stop talking about this," she writes. "In Texas schools are actually mostly open, and our organization reopened in late summer, and yet more than 80 percent of our kids now aren't reading on grade level. And the trauma and now-hidden abuse? Real."

In Texas, they can now see the children and the harm that has been done. In Texas, the closure of schools and services was minimal compared to Davis. Like her, I will not stop talking about this. Because I can't look our children's generation in the eye unless I can say that I did what I could as an adult to protect them.

Any narrative that equates closed schools with safety is a false narrative. It is a narrative that goes against the overwhelming public health guidance and leadership. Guidance which takes into account the safety and wellbeing of the ENTIRE community – teachers, staff, students, families and community members. It is a narrative that accepts harm to children. Harm that you may ignore since it's not visible to you now, as the children are not visible as black boxes on a screen (if they are on the screen at all). But it is harm we all know is there.

Remember that this is happening under your watch and leadership. That harm to children is increasing with every day that schools are closed. That other schools and districts have both prevented any deaths among students, teachers and staff from covid while also serving children in person. You have the ability and the responsibility to act to minimize the harm. You can do that by heeding public health guidance and opening schools as soon as possible.

Now that you know both that schools can be opened safely without a vaccine and that vaccines became available to teachers and staff as of February 15th, you can set a date by which schools will be open. I would propose you move to ensure schools are open by the first day after spring break, March 29th. This is six weeks after vaccines became available to teachers, allowing sufficient time for both access and preparations. Please show the community the urgency and commitment you have to the wellbeing of the children by setting a firm date to reopen schools.

Dear School Board Members:

I have written to you before to express my extreme concern about the absence of progress in returning children to the classroom. As established through much published research, each day that children are forced to continue remote learning negatively impacts their educational and social development and places them at a greater disadvantage with respect to their peers at other schools locally and within the nation who have safely resumed in-person learning despite facing similar public health conditions and without the substantial resources available by our terrific and supportive community to DJUSD. The harmful effects of remote learning are most acute on economically-distressed or single-parent families who need our support more than ever during the lingering impact of the COVID-19 pandemic. Research has also established that remote learning exacerbates the achievement gap. Put plainly, our children have borne a terrible sacrifice from this pandemic and remote learning, and DJUSD's mission of providing superior education to our children is now at a crossroads.

The most recent survey data as reported in the New York Times on Friday, February 12, 2021, finds that there is overwhelming consensus by public health professionals that students, teachers, and staff can safely be in schools now, and the nation's leading public health officials at the Centers for Disease Control and Prevention ("CDC") agree that children and adults can safely resume in person learning, even prior to vaccination, provided steps are taken with respect to spacing, ventilation, and testing, all of which DJUSD has already accomplished. For the wellbeing of our children's mental and emotional health and the overall public good of our Davis community, it is vital that DJUSD join other area schools and publicly commit that, at minimum, elementary school students will be returning to in person class during the 2020-2021 school year and that all students will be able to attend class in person in the 2021-2022 school year.

As part of this process of safely returning children to school and following the science and experts, not to mention the Biden Administration's efforts to overcome the negative impact of the pandemic, I also ask the School Board to publicly comment on the following, particularly to the extent the Board is unwilling to commit to returning our children to schools this year or even next year:

- What specific scientific or public health information is DJUSD relying upon with respect to its decision to not return children to the classroom this school year, and specifically the condition of vaccinations of teachers and staff who want them prior to a return to school?
- On what scientific or other basis is DJUSD not following the guidance by the CDC issued on Friday, February 12, 2021 that children can safely turn to classrooms now provided certain mitigation is accomplished?
- Beyond letters to the Governor and other policy leaders, what practical steps is DJUSD taking right now to facilitate DJUSD teachers obtaining vaccines, such as (1) contacting area pharmacies or vaccination sites to help arrange for vaccinations of teachers and staff at the first possible moment; (2) coordinating with teachers to ensure they are able to obtain vaccines at the earliest possible date and providing whatever financial, transportation, or other support to them that is necessary to get them vaccinated; and (3) setting and enforcing a deadline by which all teachers and staff who want them must obtain a vaccine.

I very much appreciate the public service you perform in helping guide our school systems and your efforts to look out for the safety of students, children, and staff. The goal of vaccinating the teachers and staff who want a vaccine is a worthwhile pursuit that I and I expect many others in the community very much support. But it is time that DJUSD publicly commit to following the science and the experts and returning students to school now. Our children deserve it.

Dear Davis Joint Unified School District Trustees:

Thank you for your hard work during this difficult time. In person-schools have been closed for almost a year. Time is running out on this academic year. With the growing evidence that schools can open safely during the pandemic, why are we still keeping our kids at home? Research shows that children are not major sources of coronavirus transmission. Many schools around the world and across the United States are open, and there have not been major outbreaks as a result. Most private schools in the state and our own community are open. By keeping public schools closed we are creating more social inequality.

The Davis school district is in far better shape than most districts to open. Our covid rates are much lower than surrounding areas. We have free Covid-testing available via Healthy Davis Together. They are willing to set up free testing at each school if schools would open.

We know teachers are doing their best to make Distance Learning work, but Distance Learning has been challenging for many students and parents. Parents who are working from home cannot get any work done when their kids are constantly interrupting. Parents without childcare must put their careers on hold to stay home with their kids. Many students are failing to learn the basic skills and knowledge they should be mastering at their age. My son is getting bored with school. He misses recess and playing with his friends. Schools teach not only academic knowledge but also responsibilities and social and emotional skills. Schools also provide physical activities and exercises. Kids cannot get this sitting in front of a screen.

Neither State nor Federal guidelines specify vaccines as essential for safe operation of schools. Why is the Davis school board putting such stringent conditions on reopening schools? We know vaccination is a major problem in California and Yolo County so schools should not stay closed until all teachers are vaccinated. (Of course, teachers should be given priority if enough vaccines are available).

The school year is running out. We need to act now for the health of our students. We are doing them a disservice by keeping them at home. Teachers should also be given a choice on whether they want to teach in person or online. Some teachers are ready to be back in the classroom with their students. Parents should have the right to choose whether to send their kids back to in-person school. Please open schools as soon as health guidance allows. The virus is going to be around for a while, so we cannot just sit back and wait for the "right time" to open. We may be waiting a very long time. The students are the one paying the price.
