

**MEMORANDUM OF UNDERSTANDING
BY AND BETWEEN
DAVIS JOINT UNIFIED SCHOOL DISTRICT AND CATALYST FAMILY INC.**

This MOU ("MOU") is made between the Davis Joint Unified School District, a public school district of the State of California ("District"), and Catalyst Family Inc., a private corporation. The District and CATALYST FAMILY INC. are sometimes referred to herein individually as a "Party" and collectively as the "Parties."

RECITALS

WHEREAS, CATALYST FAMILY INC. shall provide duly licensed child care and development services to children of employees of the District and to other families residing and enrolled in the District to the extent possible if enrollment numbers allow.

WHEREAS, the District, in acknowledging the importance of the child care and development services that will be made available to children of employees of the District, and to other families residing and enrolled in the District by CATALYST FAMILY INC. through the operation of the Program, and in accordance with applicable law, is hereby willing to allow CATALYST FAMILY INC. the temporary use of a portion of the School Sites as specified hereto and incorporated herein (the "Premises") pursuant to the terms and conditions set forth herein; and

WHEREAS, the Parties hereto agree that it is to their mutual benefit, and for the benefit of District families served by CATALYST FAMILY INC., for the Parties to enter an agreement providing for CATALYST FAMILY INC. to use the Premises for the operation of the Program, under the terms and conditions set forth herein.

AGREEMENT

Except as specified below, the Agreement remains unchanged.

Commencing on March 17, 2021, CATALYST FAMILY INC. agrees to provide District employees with childcare at a reduced rate of \$232.50 per week charged monthly \$1000.00- a discounted rate of service. District shall provide CATALYST FAMILY INC. with a list of District employees who will receive this reduced rate.

DJUSD agrees to pay the weekly costs for any individuals DJUSD approves for District paid services to Catalyst each month following the remittance of a monthly cost summary by Catalyst to DJUSD.

Term of Agreement. The term of this Agreement ("Term") shall be until the end of the 2020/2021 School year or June 30, 2021 unless such Term is early terminated as provided in this Agreement. If District and CATALYST FAMILY INC. agree in writing prior to the end of the Term, this Agreement may be renewed upon terms and conditions agreed to by the Parties. The License granted under this Agreement shall be deemed automatically revoked upon the expiration or earlier termination of this Agreement.
