

CONTRACT NAME: AGREEMENT BETWEEN GOOD DOCS AND DAVIS JOINT UNIFIED SCHOOL DISTRICT

BRIEF DESCRIPTION OF CONTRACT: This is an agreement between Good Docs to provide a speaker, Valerie Rod-Horse Mohl, for a speaking engagement on February 7, 2019, at the Brunelle Theatre at Davis Senior High School.

GOOD DOCS INSTITUTIONAL SPEAKING ENGAGEMENT AGREEMENT

3. TERMS OF PAYMENT: Payment to Contractor must be made within 30 days after February 7, 2019.

A) NON-REFUNDABLE CANCELLATION DEPOSIT: In case of cancellation Davis Senior High School is required to pay a fee of \$500 plus any travel expenses that have been purchased in

advance but are not refundable. These fees will be deducted from the payment of \$2,339* and the remainder will be returned.
