

CONTRACT NAME: AGREEMENT BETWEEN PLACER COUNTY OFFICE OF EDUCATION AND DAVIS JOINT UNIFIED SCHOOL DISTRICT

BRIEF DESCRIPTION OF CONTRACT: This is an amendment to the agreement approved on October 18, 2018 for consulting services that provide Positive Behavioral Intervention and Supports (PBIS) to DJUSD. This amendment reflects the participation of Marguerite Montgomery Elementary School, along with Birch Lane, North Davis and César Chávez Elementary Schools.

FISCAL IMPACT: This addition increases the training cost by \$4,500 for a total of \$19,000 for the 2018-2019 school year and the cost is included in the approved budget.


It is mutually understood and agreed by and between the undersigned contracting parties to amend the previously executed agreement as follows:

Section 2.0 Effective November 14, 2018, “Attachment A” has been updated to reflect the addition of Marguerite Montgomery School to the Tier II Plus Cohort 2 Positive Behavioral Interventions and Supports training with an increase in trainings costs of \$4,500 for a total of \$19,000 for the 2018-2019 School year.

All other terms and conditions that are not hereby amended are to remain in full force and effect.
