**RESOLUTION NO. 32-19**

**AMEND LIST OF PREQUALIFIED ARCHITECTURAL AND ENGINEERING SERVICES**

**WHEREAS**, Government Code Section 4526 provides selection of professional services of private architectural, landscape architectural, engineering, environmental, land surveying, or construction project management firms shall be on the basis of demonstrated competence and on the professional qualifications necessary for the satisfactory performance of the services required; and

**WHEREAS**, On July 1, 2016, the Davis Joint Unified School District issued a Request for Qualifications to establish a pool of pre-qualified firms to provide architectural and engineering services; and

**WHEREAS**, on November 17, 2016, the District Board approved a list of 14 pre-qualified firms to provide architectural and engineering services; and

**WHEREAS**, the 2016 Request for Qualifications stated the District reserved the right to add additional firms to the pre-qualified list if it was found to be in the best interest of the District; and

**WHEREAS**, the District Board finds it is in the best interest of the District to add specific firms to the pre-qualified list; and

**WHEREAS**, the specific firms to be added to the prequalified list have demonstrated competence and the professional qualifications necessary for the satisfactory performance of the services required; and

**WHEREAS**, all firms currently on the pre-qualified list shall remain on the list; and

**WHEREAS**, inclusion on the list of pre-qualified architectural and engineering firms does not guarantee subsequent assignment of work; and

**NOW, THEREFORE**, the District Board hereby finds, determines, declares and resolves as follows:

- I. All of the recitals set forth above are true and correct and the Board so finds and determines.
