

**CONTRACT NAME: MEMORANDUM OF UNDERSTANDING BETWEEN TO YOLO  
COUNTY OFFICE OF EDUCATION AND DAVIS JOINT UNIFIED SCHOOL DISTRICT**

**BRIEF DESCRIPTION OF CONTRACT:** This is an amendment to the MOU between YCOE and DJUSD for the Head Start Program at Valley Oak approved on June 18, 2018. This amendment is solely for the purpose of expanding the Nutritional Services to include students attending YCOE special education programs or the YCOE Alternative Education programs operated at Greengate School or Cesar Chavez Community School/Yolo County Construction Project.

The term of this amendment is effective until June 30, 2021, in accordance with the original MOU.



## **AMENDMENT TO MEMORANDUM OF UNDERSTANDING**

Reference is made to the Memorandum of Understanding (M.O.U.) entered into by the Yolo County Office of Education (YCOE) Head Start and Davis Joint Unified School District (DJUSD) effective July 1, 2018 and ending June 30, 2021. This amendment is solely for the purpose of expanding the Nutritional Services to include students attending YCOE special education programs or the YCOE Alternative Education programs operated at Greengate School or Cesar Chavez Community School/Yolo County Construction Project.

Be it known, that for good consideration the parties made the following changes effective August 1, 2019, a part of the said contract as is contained therein:

- Davis Joint Unified School District Nutrition Services Program will provide and transport breakfast and lunch for up to 75 students. All meals for these programs will be delivered to Greengate School at 285 West Beamer Street Woodland, CA 95695. Drop off will be in Building B Cafeteria area. The Alternative Education program and the Special Education program will each call DJUSD weekly in order to provide numbers of lunches required for the following week. DJUSD will clearly mark meals according to the four YCOE programs being served (Head Start, Special Education, Cesar Chavez and Yolo County Construction Project (YCCP.)) There is a refrigerator available on site for any food that needs refrigeration and DJUSD will provide Warming Containers for hot meals to be stored until needed.
- YCOE will report and make available all necessary information regarding children including enrollment forms. Students who do not qualify for the free and reduced-price meal program, will be charged according to DJUSD Free/Reduced rates. YCOE will collect payment from parents who do not qualify for free or reduced rates and will send to funding to DJUSD Nutrition Services. YCOE will be the payor of last resort for unpaid meals.

All other terms and provisions of said contract shall remain in full force and effect.

The undersigned hereby represent and warrant that they are authorized by the respective parties to execute this M.O.U.


