Terms of Agreement

COVID 19 & Cancellations: Due to the uncertainty of COVID19, Partner has the right to void this agreement if due to this threat, the decision is made to cancel our program before our anticipated start of second semester and/or whenever Partner is scheduled to re-open for the new year. Any payments made before the start date can be refunded within 60 days of receipt of written notification from Partner. If the decision is made to cancel Eye to Eye after the start-date due to COVID 19, Eye to Eye can pro-rate the school fee within this agreement according to services already delivered and provide a partial refund within 60 days of receipt of written notification from Partner. Partner will also have the option to roll-over the refundable payments into the 2021-2022 program year agreement. Any cancellations not related to COVID 19 must occur at least two (2) months prior to the agreed upon start date. Cancellations not related to COVID 19 received after the start date are non-refundable. "No shows" are non-refundable.

Payment: Payment is due within 60 days of receipt of each invoice. Eye to Eye is a tax-exempt nonprofit organization as described in Section 501 (c)(3) of the Internal Revenue Code. Tax ID #51-0570498.


Transportation: Chapter Leaders and Mentors will be responsible for arranging their own transportation to the Mentee School to participate in Eye to Eye.

Match: Partner will be matched with University of California, Davis. If a match is not provided at the time of signing this agreement, Eye to Eye will have until December 1st 2020 to find a match. If no match is found, Partner will have the opportunity to void this agreement.

Mutual Indemnity: By signing this agreement, **Eye to Eye agrees to indemnify and hold harmless Partner**, its directors, officers, employees, agents, affiliates, successors and assigns (collectively "Partner") for any and all claims for death, bodily injury and damage to tangible property caused by the sole negligence or wrongful act of Eye to Eye staff, agents or representatives, arising from the services provided. This indemnity extends, but is not limited to, any and all expenses, including attorney's fees, damages, judgments, fines and settlements.

By signing this agreement, Partner agrees to indemnify and hold harmless Eye to Eye, its directors, officers, employees, agents, affiliates, distributors, successors and assigns (collectively "Eye to Eye") from any and all liability arising from the services provided. This indemnity extends, but is not limited to, any and all expenses, including attorney's fees, damages, judgments, fines, settlements and all other amounts that Eye to Eye becomes legally obligated to pay because of any claim or claims made against Eye to Eye arising from the services provided.

POSTPONING PROGRAM LAUNCH


After carefully listening to the needs of our school partners and engaging with administrators and leaders, Eye to Eye is postponing the launch of our mentoring program to mid-year. This will give schools, students, and educators time to adjust to in-person learning and enable Eye to Eye to support schools during this transition.

YOUNG LEADERS ORGANIZING INSTITUTE GOES VIRTUAL

Because of this shift in our mentoring program launch to mid-year, and coupled with guidance against large group gatherings at Brown University, the training for student leaders and advisors will now take place virtually starting in November, and we will host a national virtual Organizing Institute from January 16-18, 2021. The virtual OI will focus on community-building, leadership development, and service.

DELIVERING MORE RESOURCES AND SUPPORT

Even though our in-person mentoring programming and training will be postponed, Eye to Eye will continue to provide virtual engagements and interventions to support our entire community. We are expanding upon our virtual art rooms, and accelerating our teacher training model to be relevant to all educators administrators, and support staff within a school community.
