SECURITY SERVICES AGREEMENT

- b) *The price for services will be locked in during the dates listed above in paragraph 2.*

3. The Contractors shall provide one (1) Guard(s) during the time period set forth in paragraph 2 above.

4. The Client shall compensate the Contractor at the rate of Eight Hundred (\$800) in total. Invoices shall be emailed to the Client at the following email address:

An invoice will be prior to service. Non-payment is in direct violation of said agreement and grounds for termination of contract.

5. The Guard(s) shall be employees of the Contractor. The Contractor shall be responsible for the hiring, supervision, scheduling and compensation of the Guard(s). The Guard(s) shall not for any purpose be deemed to be employees of the Client.

6. The Contractor agrees to indemnify and hold harmless the Client, its affiliates, officers, directors, employees and agents from all liability and damages, including cost of defense and reasonable attorneys' fees, which it or they may incur as a result of injury or damages sustained by any person arising out of the negligence or misconduct of the Contractor, its employees or agents. The liability of the

Contractor to the Client, its affiliates, officers, directors, employees and agents shall be limited to a minimum of One Million Dollars (\$1,000,000.00) per occurrence, with a Two Million Dollar (\$2,000,000.00) annual aggregate.

7. The Contractor shall maintain comprehensive general liability insurance on an occurrence basis, covering itself and its employees performing services pursuant to this Agreement in the minimum amounts of One Million Dollars (\$1,000,000.00) per occurrence, with a Two Million Dollar (\$2,000,000.00) annual aggregate, with coverage for contractual liability. The Contractor shall also maintain workers' compensation insurance for its employees. Prior to the performance of services pursuant to this Agreement, the Contractor or its insurer will provide the Client with a Certificate of Insurance showing that such coverages are in effect, upon request.
