construction and site subcontractor provided asphalt/concrete substrate for all track surfacing.

- Any survey, layout, certification, testing, or inspection costs, other than those associated with visual base inspection
- Repair or patching of any existing concrete or asphalt paving to level and fix irregularities
- Custom colors, or line packages other than what is stated in scope.
- Any sports equipment/maintenance equipment not stated in scope
- Design/ construction drawings and/ or permitting for SWPPP
- Silt Fence/Inlet protection
- Exfiltration/Infiltration trenches
- Chain-link fence work of any kind
- Testing of any kind not stated in scope of work
- Hydrology Study/ Engineered plans
- Fees and/or permits of any kind
