Hotel shall indemnify, defend, save and hold harmless Group, its affiliates and their directors, officers and employees, from and against any and all liabilities, losses, damages, costs, claims, awards, judgments, sanctions, expenses, including, but without limitation, reasonable attorneys' fees and costs, resulting from or arising from any actions or omissions or willful misconduct of the Hotel, its officers, employees, agents, contractors or the Hotel's breach of this Agreement or any of Hotel's representations contained herein, except to the extent arising from the gross negligence or willful misconduct of the Group, its officers, employees, or agents in connection with this Agreement.

**Amendments:**

No modifications or alterations of this agreement shall be effective unless made in writing and signed by both parties.

**Compliance With Laws:**

In performing under this agreement, the Group and Hotel shall comply with all applicable laws and regulations of any federal, state or local government entity.

**Authority To Sign:**

If this agreement is signed in the name of a corporation, partnership, limited liability company, association, club or society, the person signing represents and warrants to the hotel that he/she has full authority to sign such contract, and in the event that he/she is not so authorized, that he/she will personally liable for the faithful performance of this contract. This contract and any attachments constitutes the entire contract between parties with respect to the subject matter hereof and shall supersede all previous proposal both verbal and written, negotiations, representations, commitments and other communication between parties. This contract may not be released, discharged, changed or modified except in writing and signed by duly authorized representatives of both parties.
