

**RESOLUTION NO. 03-16**

(Authorizing Officers to deposit or withdraw funds from the Community Facilities District No.2 Local Agency Investment Fund (LAIF) Account)

**WHEREAS**, The Local Agency Investment Fund (LAIF) is established in the State Treasury under Government Code section 16429. 1 et. seq. for the deposit of money of a local agency for purposes of investment by the State Treasurer; and

**WHEREAS**, the Community Facilities District No. 2 (the CFD) already has an account for the deposit and withdraw of money in the Local Agency Investment Fund in accordance with Government Code section 16429. 1 et. Seq; and

**WHEREAS**, the LAIF requires that the resolution in their possession match exactly the position titles of those authorized; and

**WHEREAS**, the Auditor Controller Department at the County of Yolo transitioned to the Department of Financial Services, and the resolution LAIF possesses shows the Auditor Controller rather than the Chief Financial Officer being authorized and the Department of Financial Services would like to include additional authorized officers.
