This contract is issued on 8/5/15 and will be voided only if contact is made by phone.

USE FEES:

- Winter use fee from Dec. 15 through March 31 is \$1,675 per night.
- **Summer use fee from Memorial Day Weekend to Labor Day Weekend is \$1,450 per night.**
- The maximum number of people allowed at the Lodge is 50.
- There is a minimum 2-night rental on weekends and 3-night minimum on holiday weekends.

DEPOSIT:

A non-refundable deposit of \$500.00 payable to Young Life must be sent with this contract to 1265 Beech Street, East Palo Alto, CA 94303. The full balance of charges is due before your departure. The deposit will be kept until the Mountain Lodge staff has approved cleaning after your departure. If excessive additional cleaning is required, you will be charged \$50 per hour.

CANCELLATION POLICY:

Cancellations of this contract made between 180 and 90 days prior to the start of camp will be charged 35% of the anticipated camp revenue. Cancellations made less than 90 days prior to the start of camp will be charged 50% of the anticipated camp revenue. Cancellations received 30-60 days prior to use date are liable for 75% of anticipated rental fee. If cancellation occurs 30 days (or less) prior to arrival, the cancellation fee will be 100% of the anticipated camp revenue. If cancellation is due to inclement weather, Mountain Lodge reserves the right to manage levying the cancellation fees or forfeiture of deposit.

GENERAL REQUIREMENTS:

1. The guest group is expected to pay for any damages to the property and equipment beyond normal wear and tear, including graffiti. Any incident of graffiti vandalism will be assessed a minimum fee of \$50 per incident.
2. The guest group is expected to leave the property, including individual rooms, in a clean condition. Cleaning instructions are posted in bathrooms.
3. The following are *not* permitted on the property: pets, alcoholic beverages, illegal drugs, firearms, knives, fireworks or explosives.
4. Smoking is *not* permitted on the property.
5. **Non-Young Life groups must provide a Certificate of Insurance naming <Young Life's Mountain Lodge> as additional insured.**
6. Guests are expected to adhere to the guidelines stated above, posted on the grounds, or published in the registration information.

INDEMNITY AND CONTRACT AGREEMENT:

Your group and its sponsoring organization agree that they will not hold or attempt to hold Young Life liable for any loss, damage or injury to person or property caused by any act or neglect of other persons on or about the Property, or caused in any manner other than the willful or negligent act of Young Life, its agents and employees, and will indemnify and hold Young Life harmless from any liability for damages or claims against Young Life arising out of or in any way related to any such loss, damage or injury.

(Note: The above clause is not applicable to Young Life Groups.)

We agree to all contract conditions, rates, and regulations and acknowledge that this contract is not binding until signed by an authorized Mountain Lodge representative. We agree to respect the beliefs of Young Life as set forth in the Young Life statement of faith on the reverse side of this contract.

YOUNG LIFE'S STATEMENT OF FAITH

Preamble

All those who participate in the ongoing work and witness of the Campaign shall be in sympathy with its central purpose of proclaiming the gospel of Jesus Christ. In order to qualify for office, members of the board of directors, members of the regular and volunteer staff and professors at the Young Life Institute shall subscribe to the following articles of faith:

Article I

The Scriptures of the Old and New Testaments being given by divine inspiration, are the word of God, the final and supreme authority in all matters of faith and conduct.

Article II

In the Scriptures, God reveals himself as the living and true God, Creator of all things. Perfect in love and righteous in all His ways, this one God exists eternally as a Trinity of persons: the Father, the Son and the Holy Spirit.

Article III

God made man in His image that He might have fellowship with him. Being estranged from God by his disobedience, sinful man is incapable of a right relationship to God apart from divine grace.

Article IV

The only Mediator between God and man is Jesus Christ our Lord, God's eternal Son, who as man fully shared and fulfilled our humanity in a life of perfect obedience.

Article V

By His death in our place, Jesus revealed the divine love and upheld divine justice, removing our guilt and reconciling us to God. Having risen bodily from the dead and ascended into heaven, He rules as Lord over all and intercedes for us as our great high priest.

Article VI

The Holy Spirit, through the proclamation of the gospel, renews our hearts, persuading us to repent of our sins and confess Jesus as Lord. By the same Spirit we are led to trust in divine mercy, whereby we are forgiven all our sins, justified by faith through the merit of Christ our Savior, adopted into God's family as His children and enabled so to live in the world that men may see our good works and glorify our Father who is in heaven.

Article VII

God by His word and Spirit calls sinful men into the fellowship of Christ's body. Thus He creates the one holy, catholic and apostolic church, united in the bonds of love, endowed with the gifts of the Spirit and summoned by Christ to preach the gospel and to administer the sacraments, to relieve human need and to strive for social justice.

Article VIII

God's redemptive purpose will be consummated by the return of Christ to raise the dead, judge all men and establish His glorious kingdom. Those who are apart from Christ shall be eternally separated from God's presence, but the righteous shall live and reign with Him forever.
