

CONTRACT NAME: AGREEMENT BETWEEN DAVIS POLICE DEPARTMENT AND DAVIS JOINT UNIFIED SCHOOL DISTRICT

BRIEF DESCRIPTION OF CONTRACT: This is a joint agreement between the Davis Police Department and Davis Joint Unified School District to present a “Parent Project” program consisting of a 10-week parenting class to help parents understand and communicate with their children by providing tools to change negative or unwanted behaviors. The class will be offered at a DJUSD site and will be taught by qualified staff from both organizations.

The cost for the class is \$50 per person and includes materials.

MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT (the "Agreement") is entered into as of April 1, 2007 and updated August 19, 2015, by and between the DAVIS POLICE DEPARTMENT ("DPD") and DAVIS JOINT UNIFIED SCHOOL DISTRICT ("DJUSD").

Recital

WHEREAS, DPD and DJUSD have agreed to jointly present a "Parent Project" program consisting of a 10-week parenting class which will typically be taught once per year, to help parents understand and communicate with their children by providing concrete and concise tools to change negative or unwanted behaviors;

Agreement

NOW, THEREFORE, DPD and DJUSD hereby agree as follows:

1. DPD and DJUSD shall jointly provide the Parent Project program at a Davis Joint Unified School District site, at a cost of \$50 per person for the 10-week program. This fee includes materials.
2. The program shall be jointly taught by appropriately qualified DPD and DJUSD staff.
3. DPD will administer the program and retain 3% of total enrollment fees as a program administrative fee.
4. DPD and DJUSD will evenly divide the total class fees, minus materials costs and the program administrative fee. Materials include workbooks, minor office supplies and class food snacks.
5. DPD will provide to the DJUSD Business Office a copy of the class roster and a check for the DHS 50% share within 30 days following the last class of each class session.
6. This agreement shall be effective immediately and shall remain in effect for as long as both DPD and DJUSD agree to continue the program. Either party may terminate participation in the program at any time.
7. Modifications to the terms of this Agreement shall be in writing and executed by both parties.
