## Up to \$20,000 subsidy available for Prop 39 Services

The School Energy Efficiency (SEE) Program, one of Pacific Gas and Electric Company's (PG&E) Third Party efficiency programs administered by CLEAResult, offers substantial opportunities to help school districts save energy and money. CLEAResult understands the opportunities and barriers for energy upgrades in schools, and has partnered with PG&E to offer a Prop 39 SEE Bonus to school districts throughout PG&E's service territory.

### The Prop 39 SEE Bonus

Together, PG&E and CLEAResult are offering school districts a sensible way to save energy and money. The Prop 39 SEE Bonus (Bonus) is a limited time program offering to encourage SEE participants to submit a comprehensive Prop 39 Energy Expenditure Plan (EEP) before funds are depleted. The Bonus will help offset the cost of the EEP by subsidizing services for EEP development and submittal. Districts may apply these services to any portion of their plan developments and allow the SEE Team to act as a Resource Coordinator.

### Services include but are not limited to:

- Benchmarking
- Analysis of historical SmartMeter™ data
- Building energy assessments or audits
- Project/measure prioritization and sequencing
- Savings-to-Investment Ratio (SIR) calculations
- EEP development and submittal
- Identifying applicable utility incentives to reduce costs

## About the School Energy Efficiency (SEE) Program

Since 2006, the SEE Program has offered technical services and cash incentives to assist school districts with identifying, developing, and implementing cost-effective energy efficiency projects. Program advisors work closely with facilities managers and administrators to help choose the right options for reducing energy costs while moving school facilities towards a brighter future.

## Funding

Funds will be available on a first-come, first-served basis and the Bonus will only be available while funds last. The amount of funding support per district will be based on the Prop 39 funding allocation for the school district's Average Daily Attendance (ADA) level (tier level), district size and maximum percentage of coverage caps. The Bonus will be offered to qualifying school districts through an instant discount for services completed upon submittal of the district's EEP.

### Three simple steps to participate

- 1. Enroll:** Customer signs a SEE Access Agreement and a Prop 39 SEE Bonus Agreement to secure funds.
- 2. Implement:** The SEE Team works with the customer to determine the services needed to complete a comprehensive and site-specific EEP.
- 3. Submit:** The SEE Team submits the EEP to the California Energy Commission (CEC) and processes the Bonus.
