The funds requested will assist in providing FTEs for Animal Science pathway, release time for the instructors to collaborate, develop curriculum, and matriculate with business partners, community agencies, and postsecondary. **In-Kind** match totals \$41,200 for teacher FTEs.

**3000 employee benefits:** \$12,000 is requested to support the FTEs and release time of the instructors for collaboration time. **In-Kind** of \$12,660 is provided for animal science pathway instructor and CTE salaries.

**4000 Books and Supplies:** Davis JUSD is requesting \$15,000 in support of purchasing new textbooks, supplies and materials in support of the animal services pathway alignment with Woodland Community College and UC Davis. **In-Kind** match is provided through leveraging Perkins and LCFF funds of \$22,000.

**5200 Travel and Conferences:** Davis JUSD is requesting \$3,000 to support sending instructors to animal science pathway related trainings and conferences. **In-Kind** match will be provided by Davis JUSD LCFF and Perkins \$6,200.
