

CONTRACT NAME: CONTRACT BETWEEN KATHRYN WYFFELS AND REGINA ROSENZWEIG AND DAVIS JOINT UNIFIED SCHOOL DISTRICT

BRIEF DESCRIPTION OF CONTRACT: This contract between Kathryn Wyffels and Regina Rosenzweig and DJUSD is to provide a follow-up training for teachers at Patwin Elementary School in the Guided Language Acquisition Design model.

The training will focus on strategies aligned with Common Core and ELD Standards.

This will be a two-day training at a total cost of \$6,000 and will be paid for from the 2016-2017 Title I funds.

Project GLAD Training Service Contract

Location: Patwin Elementary, Davis Joint Unified

Refresher and ELD Follow Up: August 17-18, 2016

Description: Participants will receive intense follow up training in the Guided Language Acquisition Design model. **All teachers attending the refresher days must have previously completed the six-day GLAD training. Trainers reserve the right to enforce this rule and will ask teachers to not participate if they have not been trained in the Two-Day and Demonstration Lessons. No part of the refreshers may be recorded or videotaped.**

Description:

Refresher: Participants will participate in a Project GLAD One-Day refresher. Trainers will present GLAD focal strategies aligned with Common Core Standards. Teachers will have an hour to two hours of planning time. Emphasis on 21st Century Skills aligned with Common Core Standards will also be addressed.

ELD Refresher: Participants will participate in a Project GLAD One-Day ELD refresher, focusing on Common Core Standards and ELD Standards and ELD frames. Trainers will help teachers understand and plan for designated and integrated ELD. Teachers will have an hour to two hours of planning time. Emphasis on 21st Century Skills aligned with Common Core Standards will also be addressed.

A. Materials: Trainers will send a **handout** to be copied for the refresher. School or District also must provide each participant with a copy of his/her **grade-level ELD standards**. A projector and screen will need to be provided by the district/school. District/School will also provide materials for planning including chart paper, sentence strips and markers.

In the event that a trainer is not able to attend a session, a substitute will be provided; the absent trainer will bill for the work and pay the substitute. If a substitute is not available and one trainer provides services, the absent trainer will bill and pay the attending trainer for her services.

Cost and Payment:

Refresher/ELD Days-\$3,000 per day for 20 - \$6,000.00

Minimum number of participants: 20

Maximum number of participants: 40

\$250 per participant per day over 20

Total Cost for two refresher days for 20 participants: \$6,000.00

D. Non-payment: If payment is not received within 60 days, interest will be charged at a rate of 10% per annum until paid in full. In addition, if the matter is sent to a collection agency, it is agreed that the district will pay any and all collection costs and reasonable attorney's fees.

E. Cancellation Policy: Notice of any cancellations **must be given in writing 30 days** prior to the first scheduled workshop. After that time, the district will still be charged the full amount.

F. Entire Agreement: This contract contains the entire agreement of the parties. There are no warranties expressed or implied other than as set forth herein.
