AMENDMENT NO. 1 TO OWNER/ARCHITECT AGREEMENT

That certain Owner/Architect Agreement (Agreement) dated March 9, 2015, by and between Davis Joint Unified School District (Owner) and HMC GROUP (Architect), with respect to providing Architectural and Structural Engineering Services is hereby amended, modified, and revised as follows:

Scope of Work:

Provide additional Architectural and Structural Engineering Services at Emerson Jr. High School as follows:

- Provide additional construction drawings and coordination to break down the project into two separate DSA submittals
- Provide additional architectural services for basketball backstops.
- Provide additional architectural and structural engineering services for CCD-001 submitted to DSA. Changes to the original design as follows:
 - 1. Four (4) skylights
 - 2. Construction Administration
 - 3. Close-out
 - 4. Credit of \$3,200 for the Wood Louver Replacement that was removed from the project scope that was identified in our original Proposal.

Architect's Compensation:

Fee for the additional scope of work listed above shall be on an hourly basis not-to-exceed Seven Thousand and Ten Dollars (\$7,010), without prior written approval per Attachment "A" HMC Hourly Rate Schedule, as follows:

Raija Clar (PM): \$8,000 (50 hrs/\$160) Melinda Pendelton (Agency): \$1,350 (15 hrs/\$90) Nancy Thao (CA Support): \$ 160 (2 hrs/\$80)

Point 2: \$ 700 (Structural Engineering)
