AMENDMENT NO. 7 TO OWNER/ARCHITECT AGREEMENT

That certain Owner/Architect Agreement (Agreement) dated August 27, 2008, by and between Davis Joint Unified School District (Owner) and HMC GROUP (Architect), with respect to providing Additional Architectural and Electrical Engineering Services is hereby amended, modified, and revised as follows:

Scope of Work:

- Provide additional architectural services for two (2) separate DSA submittals (2 increments) and for two (2) bids.
- Provide additional electrical engineering services for public announcement system.

If Additional Services are required beyond the original Scope of Work, HMC will bill on an hourly basis per Attachment "A", HMC Rate Schedule.


Reimbursable Expenses:
