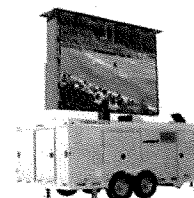

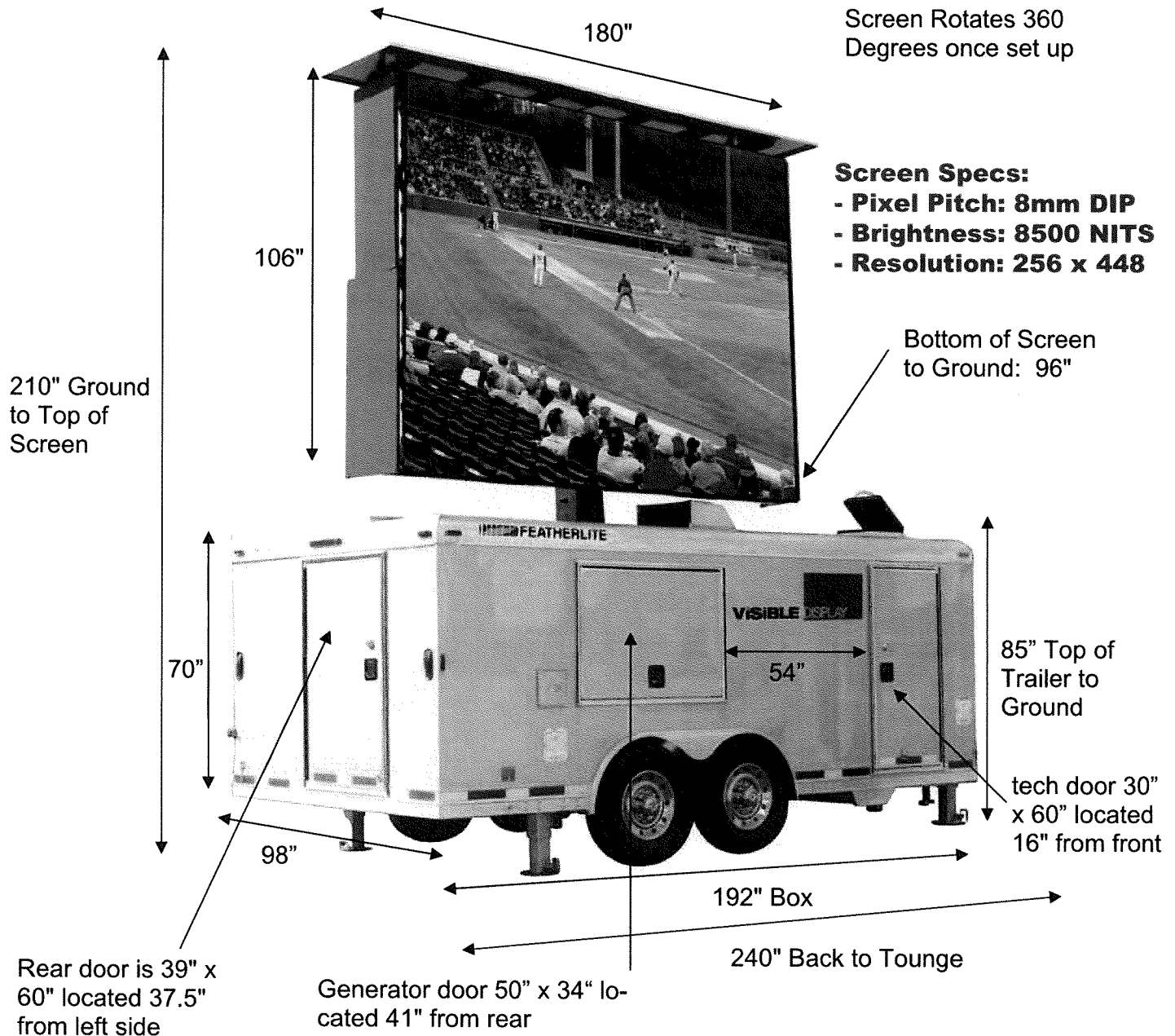

By Visible Display Corporation: For this contract to be valid, it must have an authorized signature and date by a representative from Visible Display Corporation as well as a valid client signature above.	

**DIESEL GENERATOR AND PRODUCTION SERVICES:** The Visible Display trailer runs off of a 20kw diesel generator. This is the only power available on the unit. It is the clients responsibility to insure that the venue location authorizes the use of a diesel generator. Diesel emmissions will emanate from the exhaust pipe on top of the trailer. The trailer is capable of accepting shorepower from an alternate power source. The shore power must be a minimum of 60amps, 220 Volts and have the appropriate cable connections for use with the trailer. A connection diagram can be provided upon request by the client. Unless otherwise noted, Visible Display is providing a large, mobile LED screen for the client to connect their video sources into. Unless otherwise noted in the contract, Visible Display does not provide video, camera or any other types of production services. The content that will be displayed for the screen is the sole responsibility of the client. Client is responsible in providing video signal to each screen location. If client is using multiple screens, Visible Display is not responsible to provide any type of video/audio connection between each of the screens.

**LEGAL TERMS AND CONDITIONS:** **CANCELLATION:** Once deposit funds have been received by Visible Display Corporation, hereinafter VDC, the amount is considered non-refundable. **CONTENT & LICENSING:** All content displayed (Audio and Visual) on the Visible Display is the sole responsibility of the Rentor of the Visible Display. VDC will be held harmless from any legal issues arising from content used due to but not limited to trademark infringement, licensing issues, decency laws and/or any other issues arising from the content in question. Client is responsible to obtain any and all permits, licenses and/or any other forms of authorization to utilize the Visible Display in the location and/or locations that the equipment will be set-up. Events that are canceled or shut down during use due to the lack of proper licensing, permitting or authorization from the local authority shall be the sole responsibility of client.

**INDEMNITY:** VDC is not responsible for any real or implied financial loss due to the fact that VDC fails to perform under this contract. If equipment is damaged in transit, fails to operate while on site or in any other degree does not perform the functions the equipment was manufactured to perform, VDC is in no way financially obligated to rentor in excess of any deposits or payments made in regards to the rental. If this contract is for multiple units and/or multiple days or events, VDC is in no way financially obligated to rentor any sum of money beyond the failed single unit pro-rated amount for that individual occurrence. **INSURANCE:** Rentor is required to furnish to Visible Display Corporation a certificate of insurance showing VDC as an additional insured in regards to the equipment as well as liability associated with the equipment. If requested, VDC agrees to add named client in this contract as an additional insured to Visible Display's commercial insurance. If above listed client requires more than one entity to be named, venue or any other party requires to be added as an additional insured to Visible Displays commercial insurance, a charge of \$150 per named entity will be charge by Visible Display.

NOTES: Trailer is fully self-contained with generator, production booth and a small sound system (For an audio range of appx. 50 yards from trailer) The switcher can accept almost any type of video signals from HDMI, HDSDI, SDI, VGA, Composite Video, etc. Trailer is fully operational within 45 minutes of placing the trailer in the location. Technician stays onsite with the trailer during the event.
