Any and all information or details shall be communicated before five days before the event.

The DJ shall not be held liable for any action that may arise from or in connection with any individual that is not directly affiliated with the DJ.

HOLD HARMLESS CLAUSE

Emerson and Da Vinci School students, faculty, guests and chaperones are not responsible or liable for any injuries or damages caused to Leonard Purdy (DJ) or his assistants that are performing for the evening.

CONTRACTOR CLAUSE

Status. Leonard Purdy (DJ) is an independent contractor. Nothing contained in this Agreement shall be construed to create the relationship of employer and employee, principal and agent, partnership or joint venture, or any other fiduciary relationship.

No Authority. Consultant has no authority to act as agent for, or on behalf of, Emerson and Da Vinci School, or to represent Emerson and Da Vinci School, or bind Emerson and Da Vinci School in any manner.

No Benefits. Leonard Purdy (DJ) will not be entitled to worker's compensation, retirement, insurance or other benefits afforded to employees of Emerson and Da Vinci School.



INDEMNIFICATION:

Insofar as permitted by law, DJUSD shall assume the defense and hold harmless Purd Man Entertainment and/or any of its officers, agents or employees from any liability, damages, costs, or expenses of any kind whatsoever, including attorneys' fees, which may arise by reason of the sole fault or negligence of DJUSD, its officers, agents or employees, arising out of its performance under the terms of this agreement.

Insofar as permitted by law, Purd Man Entertainment shall assume the defense and hold harmless DJUSD and/or any of its officers, agents or employees from any liability, damages, costs, or expenses of any kind whatsoever, including attorneys' fees, which may arise by reason of any harm to person(s) or property received or suffered by reason of the sole fault or negligence of Purd Man Entertainment, its officers, agents or employees, arising out of their performance under the terms of this agreement.
