

**CONTRACT NAME: ADDENDUM BETWEEN  
COMMUNICARE HEALTH CENTERS AND DAVIS JOINT  
UNIFIED SCHOOL DISTRICT**

**BRIEF DESCRIPTION OF CONTRACT:** This is an addendum to the agreement approved at the October 20, 2016 Board meeting between CommuniCare Health Centers and DJUSD. The agreement is being revised to include the cost of equipment and medical supplies.

This addendum increases the dollar amount from \$1,500 to \$3,500 and will be funded through LCAP supplemental funding.

As outlined in the Agreement for Services, Davis Joint Unified School District/Martin Luther King (Jr.) High School will also reimburse CommuniCare for medical supplies and medical equipment expenses, medications and lab services. The original agreement was for up to \$1,500 for services provided for the duration of the contract.

This revision increase the dollar amount from \$1,500 to \$3,500 in order to accommodate initial one-time purchases for equipment (including: microscope, exam light, vital signs monitor, otoscope and nebulizer compressor) set-up and inspection of equipment.

## **Agreement for Services**

This is a Letter of Agreement between the Davis Joint Unified School District/Martin Luther King (Jr.) High School and CommuniCare Health Centers.

### **Goal:**

To expand the health care services offered at Martin Luther King (Jr.) High School in the Davis Joint Unified School District by contracting with CommuniCare Health Centers, Inc. (CommuniCare), a non-profit health care center, to provide limited primary health care services, including sexual and reproductive health services, that will enhance student health at Martin Luther King (Jr.) High School through the use of direct patient care, education, skills, and human and material resource allocation.

### **Objective:**

To improve access to quality clinical health care services for Martin Luther King (Jr.) High School students in collaboration with CommuniCare, a local Federally Qualified Health Center (FQHC), to prevent illness and promote wellness so that students may achieve their academic and personal goals. This will remove serious physical barriers to free student's minds to be able to learn in a school environment.

### **Payment:**

Davis Joint Unified School District/Martin Luther King (Jr.) High School will pay CommuniCare Health Centers the amount of \$75 per hour for up to 144 hours for primary care medical services provided on campus for the months of October, November and December 2016 and January, February, March, April and May 2017 as listed in ADDENDUM A – HOURS OF SERVICE AND REIMBURSEMENT. Davis Joint Unified School District/Martin Luther King (Jr.) High School will also reimburse CommuniCare for expendable medical supplies, medications and lab services for up to \$1,500 for services provided for the duration of this contract. Services will begin October 22, 2016 through June 30, 2017. Payment will be processed at the end of each month from a monthly invoice submitted by CommuniCare.

### **Provisions:**

Davis Joint Unified School District/Martin Luther King (Jr.) High School will supply an agreed upon facility to include a working restroom, separate examination room with sink and an adjacent office/intake room. Davis Joint Unified School District/Martin Luther King (Jr.) High School will also provide a computer/printer, locking cabinets, locking file cabinet, desks/chairs, small refrigerator, otoscope, exam light, and all necessary office supplies and custodial services. CommuniCare will provide some medical equipment an exam table, doctor's chair, scale, medical records, medical and lab supplies and medications necessary to run the clinical health services on campus. All of the medical equipment supplied by CommuniCare and the patient medical records will remain the property of CommuniCare. Assessment and calibration of equipment will be conducted annually or as required by law and will be paid for by CommuniCare.

Martin Luther King (Jr.) High School will work to publicize student health services in conjunction with CommuniCare Health Centers. This may include information in campus newsletters and on the website, fliers and brochures around campus, and presentations in appropriate classes.

**Nature and Scope of Agreement:**

- a. Davis Joint Unified School District/Martin Luther King (Jr.) High School will allow CommuniCare Nurse Practitioner(s) (N.P.), Physician Assistant(s) (P.A.), or Physician to have access to its campus for the purpose of making primary clinical health care services available to students currently enrolled at Martin Luther King (Jr.) High School. Services will be provided one day every week for up to 4 hours per week during the months of October – December 2016 and January – May 2017. A commonly agreed upon schedule will be developed between CommuniCare Health Centers and Martin Luther King (Jr.) High School which may vary from the above named days and hours. See attached ADDENDUM A – HOURS OF SERVICE AND REIMBURSEMENT.

**Further Nature and Scope of Agreement**

- Obtaining written parental consent for limited primary health care (with the exception of confidential sexual and reproductive health services protected by law) will be the responsibility of the student and Martin Luther King (Jr.) High School.
- Services to be provided will be limited primary health care including sexual, reproductive, and preventative care, appropriate referrals, and health education. CommuniCare Health Centers will operate under approved medical protocols in the provision of health care services.
- CommuniCare Health Centers will be responsible for the personnel costs of conducting such services, including but not limited to salaries, benefits, and administrative overhead costs.
- CommuniCare Health Centers will not charge students for consultations/examinations.
- Students may be referred for medically necessary additional or ancillary services not provided on campus, such as lab tests, X-rays, medications, specialty care services, etc. The costs of these services will be the responsibility of the student and/or the student's parents or legal guardian(s).
- CommuniCare Health Centers will not disclose to any person or entity any confidential student record information or other confidential information it acquires as a result of providing health care services to students, except when strictly adhering to the HIPAA privacy rule.
- CommuniCare Health Centers will procure and maintain insurance against all claims, including but not limited to claims for injuries to persons and damage to property. The Federally Qualified Health Center will secure at its own cost the following insurance coverage:

- a. **General Liability:** Commercial board form general liability insurance written on an "occurrence" policy form, covering bodily injury, property damage, personal injury and advertising injury arising out of or related (directly or indirectly) to CommuniCare Health Centers' business operations, conduct, assumed liability, or use or occupancy of the premises with coverage of at least \$1 million. Martin Luther King (Jr.) High School to be named as additional insured.
- b. **Professional Malpractice:** Professional medical malpractice insurance with limits of at least \$1 million per occurrence and \$3 million aggregate. Martin Luther King (Jr.) High School to be named as additional insured.
- c. **Worker's Compensation and Unemployment:** CommuniCare Health Centers will maintain worker's compensation as required by law. See attachment BIDDER'S CERTIFICATE REGARDING WORKER'S COMPENSATION.
- d. **Verification of Insurance:** CommuniCare Health Centers will provide certificates of insurance at the time of contract award.
- e. **Student Medical Records:** The medical records of all students seen on campus by the CommuniCare practitioners will remain the property of CommuniCare and will not be shared with anyone else or with any other entity, including Martin Luther King (Jr.) High School staff, without written consent of the student.

CommuniCare Health Centers providing primary health care services at Martin Luther King (Jr.) High School holds Davis Joint Unified School District harmless from claims which may arise in connection with the operation of CommuniCare Health Centers facilities specified herein and health care performance of any service under this contract; except for claims caused by Davis Joint Unified School District or any of its employees, agents or representatives, for which Davis Joint Unified School District shall hold CommuniCare Health Centers harmless.

### **Terms**

This agreement shall commence on October 22, 2016 and run through June 30, 2017. This agreement may be canceled by a 30 day written notice by either party or modified with mutual consent.
