

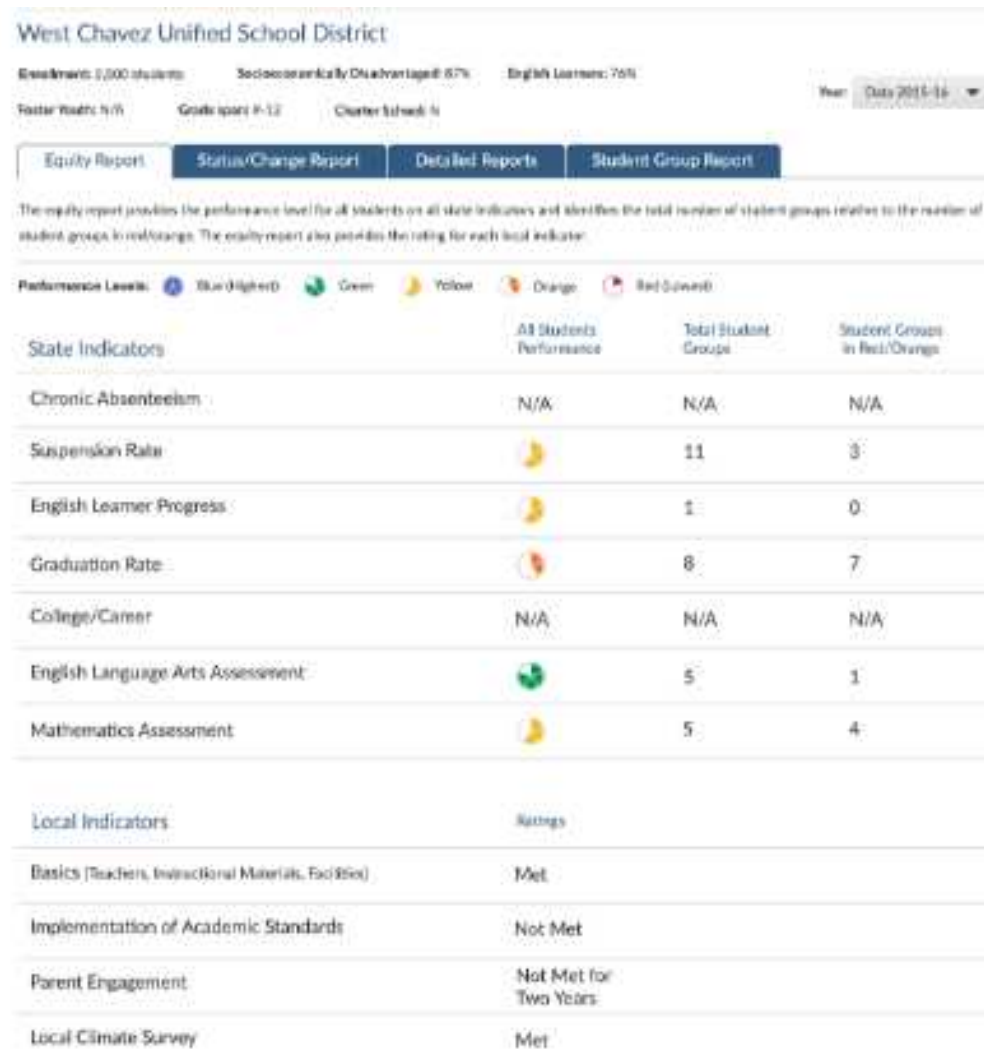

nor the LEVEL of progress on a tool...

Meeting standard is about **engagement**
in the **process, analysis for continuous**
improvement, transparent reporting of
results, and the expectation to
incorporate into the plan.

Getting to “Met”: Basic Services

<i>Frequency:</i>	Annually
<i>Indicator:</i>	Measures district progress meeting basic services
<i>Accountability:</i> <i>Reporting to Board</i>	Reports results to governing board at a regularly scheduled public meeting
<i>Accountability:</i> <i>Reporting to Stakeholders</i>	Reports results to stakeholders and public through evaluation rubrics
<i>Tool:</i>	District and School Accountability Report Cards

Getting to “Met”: Implementation of State Academic Standards

<i>Frequency:</i>	Annually
<i>Indicator:</i>	Measures progress implementing state academic standards
<i>Accountability: Reporting to Board</i>	Reports results to governing board at a regularly scheduled public meeting
<i>Accountability: Reporting to Stakeholders</i>	Reports results to stakeholders and public through evaluation rubrics
<i>Tool:</i>	State Developed Reflection Tool

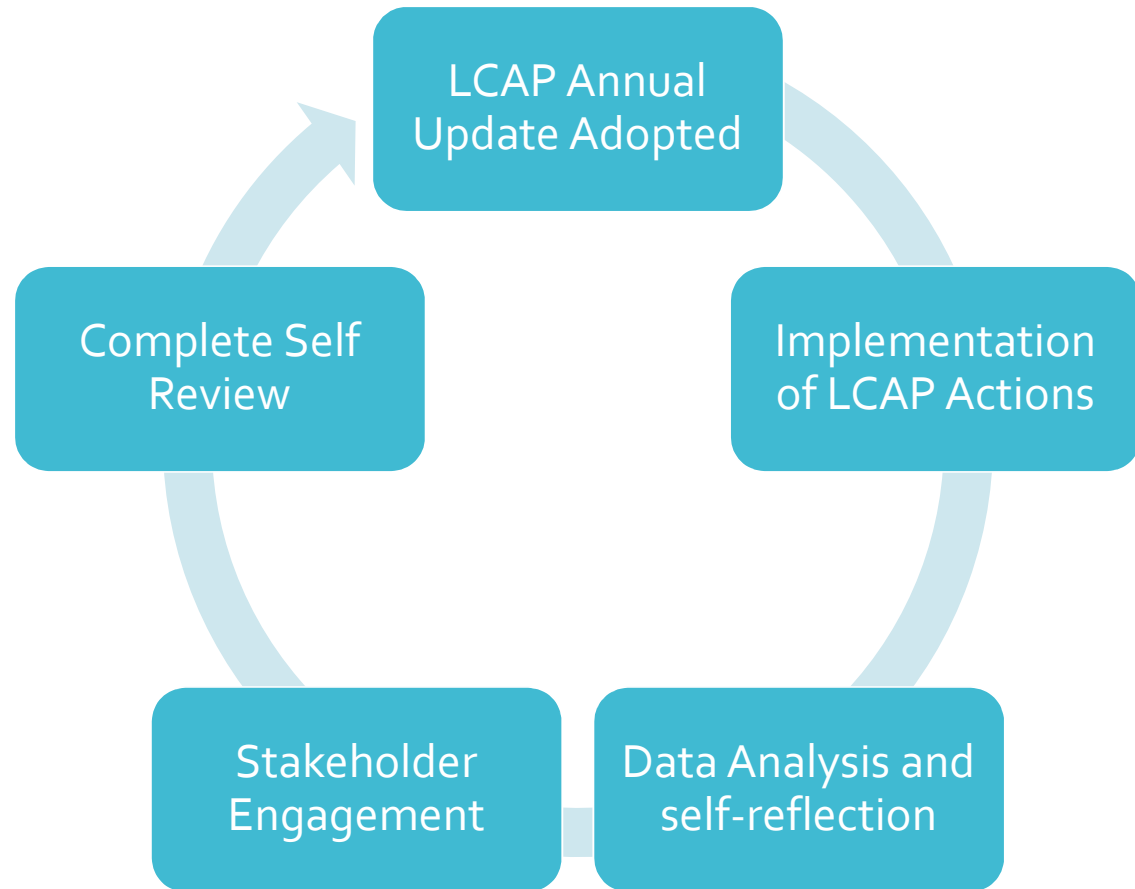
Getting to “Met”: Parent Engagement

<i>Frequency:</i>	Annually
<i>Indicator:</i>	Measures progress in 1) seeking input from parents in decision making; and 2) promoting parental participation in programs
<i>Accountability:</i> <i>Reporting to Board</i>	Reports results to governing board at a regularly scheduled public meeting
<i>Accountability:</i> <i>Reporting to Stakeholders</i>	Reports results to stakeholders and public through evaluation rubrics
<i>Tool:</i>	Reflection Tool summarizes key findings from local survey related to seeking input from parents

Getting to “Met”: School Climate

<i>Frequency:</i>	Annually
<i>Indicator:</i>	Measures progress in developing a positive school climate
<i>Accountability:</i> <i>Reporting to Board</i>	Reports results to governing board at a regularly scheduled public meeting
<i>Accountability:</i> <i>Reporting to Stakeholders</i>	Reports results to stakeholders and public through evaluation rubrics
<i>Tool:</i>	Reflection Tool summarizes finding from school climate surveys
