Contract Terms

To guarantee rates quoted, the availability of sleeping rooms requested and all other terms of this contract, this contract must be signed and returned to the hotel by 03/13/2017 or the rooms may be canceled.

Reservation requests above the agreed block or received after the Cut-Off Date will be based on availability at the Hotel's prevailing rates and will be credited to the Group's Sleeping Room Block

Once this contract is signed, the cancellation policy and attrition clause, below, will be in effect.

Guest Room Attrition

Davis High School Track & Field agrees to provide a daily minimum dollar amount of guest room revenue which shall be equal to 80% of the number of guest room nights per each day set forth in the Guest Room Accommodation chart. Should Davis High School Track & Field fall below this amount, Davis High School Track & Field will pay as a reasonable estimate of the Hotel's losses an amount equal to the difference between 80% of the Minimum Revenue and the actual guest room revenue achieved by Group (the "Attrition Damages"). For example, if Davis High School Track & Field Contracts ten (10)

rooms per day but only seven (7) rooms are reserved and consumed by Davis High School Track & Field , the Attrition Damages owed will be one (1) room at \$229.00 for each day that 80% is not met. All applicable Attrition Damages will be paid by Davis High School Track & Field.

Force Majeure

The Performance of this Agreement is subject to termination without liability upon the occurrence of any circumstances beyond the control of either party-such as acts of God, war, government regulations, disaster, strikes (except those involving the employees or agents of the party seeking the protection of this clause), civil disorder, or curtailment of transportation facilities-to the extent that such circumstance makes it illegal or impossible to provide or use the Hotel Facilities. The ability to terminate this Agreement without liability pursuant to this paragraph is conditioned upon delivery of written notice to the other party setting forth the basis for such termination as soon as reasonably practical- but not longer than ten (10) days- after learning of such basis.

Cancellation Policy

All cancellation must be received in writing, if this booking in its entirety or any portion of it becomes necessary. To avoid forfeiture of any deposits paid or payment of penalties, the hotel must receive written notification before **03/19/2017**. **Otherwise the above attrition clause will be in effect.**

Check-In/Check-Out Times

Check-In time is 4:00 p.m. or later. Anyone arriving prior to 4:00 p.m. will be accommodated as soon as possible, but should be advised that there may be a wait. Check-out time is 12 noon. Arrangements can be made for baggage storage with our front desk staff.
