Re: Your group's stay for October 2017

Thank you for choosing Grand Legacy At The Park for your groups housing needs. The dates requested are October 20th 2017 for 2 nights departing on October 22nd 2017. We will be blocking **30 rooms** total. Per our agreement, 30 Deluxe Two Queen Bed rooms will be at the contracted net rate of **\$130.00 plus 17% taxes/fees** per room, per night. These rates are valid for 14 days after contract date. Group agrees to be mindful with noise and activity, especially during the quiet time of 10pm through 7am. Rate includes Wi-Fi and Snack Bag.

Parking is an additional \$15.00 per vehicle per night plus 17% taxes/fees and bus parking is an additional \$50.00 per bus per night plus 17% taxes/fees.

We require a deposit of **\$4,563.00** due on August 20th 2017. If we do not receive the deposit by this date, group bookings will be automatically canceled. We require the remaining balance of **\$4,563.00** due by September 20th 2017. If we do not receive final payment by agreed date, we will automatically cancel the entire group booking. We also require a detailed rooming list by September 20th 2017.

Group bookings may be canceled with no penalty up until **30 days of arrival**. Changes in rooms and nights may be made up until this time with no penalty. After **September 20th 2017**, no cancellations or changes will be allowed. If you cancel or change the entire group reservation or any portion thereof, the total balance will be forfeited.
