

**CONTRACT NAME: AGREEMENT BETWEEN JAMZ AND  
DAVIS JOINT UNIFIED SCHOOL DISTRICT**

**BRIEF DESCRIPTION OF CONTRACT:** This is an agreement between JAMZ and Davis Joint Unified School District for Davis Senior High School to sponsor two cheerleading competitions on Saturday, November 11, 2017 and Saturday, January 13, 2018.

**FISCAL IMPACT:** There is no cost for this agreement and the Davis Senior High School Competition Cheerleading Team will not be charged competition fees for these two events.

### **Agreement of Terms for High School Sponsorship of JAMZ Cheerleading Competitions in Compliance with CIF Rules and Regulations Regarding Sanctioning of Events.**

THIS AGREEMENT (the "**Agreement**") is entered into on this 5th day of October by and between JAMZ American Spirit Connection, Inc. ("JAMZ"), located in Modesto, CA, and Davis Senior High School, located at 315 W 14th St, Davis, CA 95616.

Davis High School Agrees to act as the Sponsoring School in compliance with CIF Sanctioned Events Standard for the following JAMZ Cheerleading Competitions:

1. JAMZ Battle of the Capitol- November 11, 2017 at Sacramento Memorial Auditorium
2. JAMZ Adrenaline- January 13, 2018 at UC Davis Pavilion

#### **• JAMZ Duties and Responsibilities**

- JAMZ will assist and support Davis Senior High School and its Athletic Director in all support needs for documentation related to the Sponsorship under CIF and/or Davis Unified School District rules and regulations for the Davis Senior High School Sponsored JAMZ Cheerleading Competitions.
- JAMZ will provide the production of Registration Documents, Contact information for each competing High School Coach/Advisor and Rosters of ALL High school teams attending the Davis Senior High School Sponsored JAMZ Cheerleading Competitions to Davis Senior High School
- JAMZ will name Davis Senior High School and Davis Joint Unified School District as an additional insured for the Davis Senior High School Sponsored JAMZ Cheerleading Competitions on the JAMZ Insurance Policy.
- JAMZ will ensure all teams attending the Davis Senior High School Sponsored JAMZ Cheerleading Competitions are in compliance with CIF and NFHS/AACCA rules and regulations, with any violations being reported to Davis High School.
- JAMZ will ensure the Davis Senior High School Sponsored JAMZ Cheerleading Competitions are ran in compliance with all CIF regulations and all NFHS/AACCA safety regulations
- JAMZ will provide at least 1 AACCA/NFHS Safety Spirit Certified Official at the Davis Senior High School Sponsored JAMZ Cheerleading Competitions.
- JAMZ General Counsel, David Sims will personally attend the Davis Senior High School Sponsored JAMZ Cheerleading Competitions to ensure proper compliance with CIF and NFHS/AACCA Safety Rules and Regulations.
- JAMZ will provide Davis High School Cheerleading team waived competition registration fees for the Davis Senior High School Sponsored JAMZ Cheerleading Competitions.



- **Davis Senior High School Duties and Responsibilities**

- Agrees to Sponsor the JAMZ Battle of the Capitol and JAMZ Adrenaline Cheerleading competitions in compliance with CIF and Davis Joint Unified School District rules and regulations regarding School Sponsoring Competitions and Sanctioned Competitions.
- Submit any paperwork that is required, with the assistance of JAMZ staff, that may be required by the CIF or Davis Joint Unified School District
