ADDENDUM
AGREEMENT FOR CONSULTANT SERVICES

ADDENDUM to Agreement dated August 2017 between LEADERSHIP ASSOCIATES, hereinafter called the Contractor, and DAVIS JOINT UNIFIED SCHOOL DISTRICT hereinafter called the District.

The Contractor agrees to perform additional services for the District as follows:

Additional meetings as required with individual Board members, the Board, and the Superintendent to strengthen the work of the governance team and develop greater clarity on roles and responsibilities of the Superintendent and the Board."

The District agrees to pay the Contractor **THREE THOUSAND DOLLARS (\$3,000) plus expenses not to exceed \$1,000** for services provided. The Contractor will submit an invoice to the District upon completion of the additional services. Payment is due within 30 days of receipt of invoice.

Contractor agrees to hold harmless and indemnify the District, its officers, agents, and employees with respect to all damages, costs, expenses or claims, in law or in equity, arising or asserted because of injuries to or death of person or damage to, destruction, loss, or theft of property arising out of faulty performance of the services to be performed by Contractor hereunder.

It is expressly understood and agreed to by both parties hereto that the Contractor, while engaged in carrying out and complying with any of the terms and conditions of this contract, is an independent contractor and is not an officer, agent, or employee of the aforesaid District. Either party may terminate this agreement by providing the other party with ten (10) days written notice. Upon such termination, fees will be determined on a pro rata basis.

Leadership Associates does not participate in a California public pension system. Leadership Associates and the District understand that the work/services provided should not be considered creditable toward the STRS earnings limit as the work is not normally performed by employees of the District and requires less than 24 months (496 business days). REF. CA Education Code § 26135.7(2014)
