EVENT DESCRIPTION

Swamp Tour

Includes an approximately one and one half (1.5) hour narrated tour by boat in the Manchac Swamp. Tour this privately owned wildlife refuge in a comfortable, covered boat, walking room, and open viewing from any seat. Swamp creatures are unafraid and responsive to our captain's voice. In the safety and comfort of the boat, you will be able to get within a few feet of our "jumping gators". Other animals to be on the lookout for include nutria, ibis, turtles, herons, raccoons, egrets, and more. Remember, alligators do hibernate in cold weather.

RESERVATION CUT-OFF DATE: A final headcount is required seven (7) days prior to the group tour/event. You can exceed your count with advance notification, if space and additional services are available. Group agrees to pay for any additional people over and above the final headcount. If a guarantee is not given to Cajun Pride Tours, the last estimated number would be used.

DEPOSIT POLICY

Cajun Pride Swamp Tours requires a 30% non-refundable deposit to hold space for each group. The deposit should be paid in conjunction with the signed contract in order to secure your group/event on a definite basis.
