HOLD HARMLESS CLAUSE

Emerson and Da Vinci School students, faculty, guests and chaperones are not responsible or liable for any injuries or damages caused to Daniel Marquez (DJ) or his assistants that are performing for the evening.

CONTRACTOR CLAUSE

Status. Daniel Marquez (DJ) is an independent contractor. Nothing contained in this Agreement shall be construed to create the relationship of employer and employee, principal and agent, partnership or joint venture, or any other fiduciary relationship.

No Authority. Consultant has no authority to act as agent for, or on behalf of, Emerson and Da Vinci School, or to represent Emerson and Da Vinci School, or bind Emerson and Da Vinci School in any manner.

No Benefits. Daniel Marquez (DJ) will not be entitled to worker's compensation, retirement, insurance or other benefits afforded to employees of Emerson and Da Vinci School.

Applicable Law


This contract shall be governed by the laws of the State of California in Yolo County and any applicable Federal Law.
