#### HOLD HARMLESS CLAUSE

#### CONTRACTOR CLAUSE

**Status.** Daniel Marquez (DJ) is an independent contractor. Nothing contained in this Agreement shall be construed to create the relationship of employer and employee, principal and agent, partnership or joint venture, or any other fiduciary relationship.

**No Authority.** Consultant has no authority to act as agent for, or on behalf of, Emerson and Da Vinci School, or to represent Emerson and Da Vinci School, or bind Emerson and Da Vinci School in any manner.

**No Benefits.** Daniel Marquez (DJ) will not be entitled to worker's compensation, retirement, insurance or other benefits afforded to employees of Emerson and Da Vinci School.
