Thank you for choosing Grand Legacy At The Park for your groups housing needs. The dates requested are Friday October 19th 2018 for 2 nights departing on Sunday October 21st 2018. We will be blocking **30 rooms** total. Per our agreement, 12 Deluxe Two Queen Bed rooms and 18 Premier Two Queen Bed rooms will be at the contracted net rate of **\$143.00\*** per room, per night. These rates are valid for 14 days after contract date.

We require a deposit of **\$5,019.30** due on August 24th 2018. If we do not receive the deposit by this date, group bookings will be automatically canceled. We require the remaining balance of **\$5,019.30** due September 19th 2018. If we do not receive final payment by agreed date, we will automatically cancel the entire group booking. We also require a detailed rooming list by September 19th 2018.

Group bookings may be canceled with no penalty up until **30 days of arrival**. Changes in rooms and nights may be made up until this time with no penalty. After **September 19th 2018** no cancellations or changes will be allowed. If you cancel or change the entire group reservation or any portion thereof, the total balance will be forfeited.

Parking is an additional \$15.00\* per car/per night and bus parking is \$75.00\* per bus/per night. Group agrees to follow 'House Rules for Groups' attached. The following amenities are included in the room rate:

## HOUSE RULES FOR GROUPS

Welcome to Grand Legacy At The Park. Thank you for choosing our hotel to accommodate your group while you are in Anaheim. To ensure the safety and comfort of all hotel guests during this time, we have outlined some guidelines. As the adult(s)/chaperone(s) responsible for the safety and welfare of the youth, you should find these guidelines helpful and reasonable. Please take a few moments to review them, share the information with your group, then sign, date, and return this form.

- Room keys will be given to chaperones/group leader at check-in only. No room keys will be issued to anyone under 18 at any time.
- We ask that large groups do not congregate around the main entrance doors to the lobby. This blocks the entry/exit for other hotel guests.
- Fire alarms are to be used only in case of a true emergency. Any false alarm will be investigated by the Anaheim Fire Department and the cost of responding to an intentional false alarm will be passed on to the person(s)/group responsible.
- A curfew of 10:00 P.M. has been established for all guests under 18. This "in room/quiet time" (10:00 P.M. through 7:00 A.M.) is to ensure the health and safety of the youth and to allow appropriate operation of the hotel.
- There is no running, shouting, roughhousing or horseplay accepted while on the hotel property. This includes hallways, lobby areas, stairways, elevators, food service areas and guest rooms.
- No sports equipment should be brought on property. Skateboards, footballs, baseballs, soccer balls, bats and such can be serious safety hazards inside the building for both the youth and for other hotel guests.
- Elevators are to be used for the sole purpose of transporting guests and their luggage to the appropriate floor of the hotel. Misuse and horseplay will not be allowed (absolutely no jumping is allowed in the elevators). Any and all costs associated with an elevator trouble call to the service provider will be passed onto the group.
- Towels for the pool are in the pool area. Towels from your guest room are not be taken to the pool area.
- Pool hours and guidelines are posted in the Guest Directory and in the pool area. All rules and time will be enforced to allow efficient operation of the hotel and for the comfort and safety of all guests.
- We are a 100% smoke free hotel. Smoking in a guestroom will result in an additional \$150.00 cleaning charge.
