

CONTRACT NAME: AGREEMENT BETWEEN BLAIR'S WATER SERVICES AND DAVIS JOINT UNIFIED SCHOOL DISTRICT

BRIEF DESCRIPTION OF CONTRACT: This agreement provided operations and distribution certification for the water treatment system serving Fairfield Elementary School, in accordance with Yolo County requirements.

FISCAL IMPACT: The cost of this agreement is included in the approved Maintenance and Operations budget.

Service Agreement

This agreement is entered into by and between Blair's Water Services (BWS}, service provider, and Fairfield Elementary School 26960 County Rd 96, Davis, Ca 95616, client, this 20th day of September, 2018

BWS agrees to provide water treatment system oversight, consulting and limited service as follows:

- Provide required operations and distribution certification for the water treatment system serving Fairfield Elementary School, Davis, Ca.
- Collect and submit required samples to a certified laboratory for analysis.
- Perform minor on-site verification tests and readings for support of monthly reports.
- Review sample results to assure compliance with regulations.
- Troubleshoot recognized operational problems related to the water treatment system.
- Prepare and submit routine and requested regulatory documents related to the water treatment system.
- Communicate and correspond with regulatory agencies as requested or required.
- Provide recommendations for system improvements with an emphasis on public health and safety and system reliability.
- Provide telephone availability for emergencies or consultation.

Fairfield Elementary School, Davis, Ca agrees to provide BWS access to facilities, laboratory results and any historical records, maps, plans, or correspondence related to the water system required for the purposes of providing the services previously described. BWS agrees to maintain confidentiality regarding any records, documents or information provided as indicated. Owner agrees to continue to perform, and provide the onsite daily data collection and submit that data to BWS for purposes of monthly reporting. Owner's responsibility to provide proper routine maintenance to the water treatment plant and distribution system in accordance with Federal and State regulatory compliance and any inspection report findings per regulatory inspector.

Services will be provided to Fairfield Elementary School, Davis, Ca at the standard service rate of \$85.00 per billable hour, billed monthly and due upon receipt, for services provided.

Typical monthly billing will consist of the following:

- 1 hour (total) monthly service visit to the site that will consist of recording appropriate data; collect and deliver required samples for laboratory analysis; conduct field verification sampling of parameters as deemed appropriate or required by permit; record chemical usage and inventory for operational purposes and replenish if required.
- ½ hour (total) per month review of laboratory results, field testing sample preparation and monthly report preparation and submission to the State.

Service Agreement (Continued from previous page)

- Laboratory testing fees per laboratory invoice and a \$5 setup and handling fee per sample. (Typical laboratory testing fees including setup and handling fee are: Bacteriological \$25. Nitrate \$25 and Nitrite \$25).
- Additional services will be provided on an as needed basis at the request of, and with prior authorization from Fairfield Elementary School, Davis, Ca .(i.e. onsite Federal or State inspections with sanitary engineer; new regulatory water quality/equipment compliance testing or reporting; required tasks listed on the last state inspection report that is still outstanding; equipment failure due to lack of maintenance that require oversite; design and implementation to existing or new safety or operation programs required).

Mileage: Mileage is included in routine site visits. Additional service requiring travel will be reimbursed at the current IRS rate for mileage.

Materials/Outside Services: Costs for materials purchased by BWS with prior approval from Fairfield Elementary School, Davis, Ca and for use by or on behalf of Fairfield Elementary School, Davis, Ca will be reimbursed at the cost of those materials supported by invoice plus service time required for the acquisition of those materials. Costs for outside services (i.e. laboratory analyses) purchased by BWS with prior approval from Fairfield Elementary School, Davis, Ca, and for use by or on behalf of Fairfield Elementary School, Davis, Ca, will be reimbursed at the cost of those services supported by invoice.

Documents and records: BWS will provide owners with copies of all correspondence and records related to system operations generated by BWS.

BWS assumes no liability for the quality or quantity of water being treated by the system or for any injury or damage suffered as a result of failure of any component of the water system, beyond the control of BWS.

Upon 15 days written notice, this agreement may be terminated by either party for any reason.
